First Amendment and Censorship

David Orentlicher is the Judge Jack and Lulu Lehman Professor of Law at UNLV William S. Boyd School of Law and director of the UNLV Health Law Program. Widely recognized for his expertise in health law and constitutional law, Dr. O has testified before Congress, had his scholarship cited by the U.S. Supreme Court, and has served on many national, state, and local commissions. He also was a health policy adviser for the presidential campaigns of Barack Obama and Joe Biden.


Since November 2020, Dr. O has served in the Nevada Assembly, and between 2002 and 2008, he served in the Indiana House of Representatives. He has authored legislation to reduce deaths from opioid overdose, promote job creation, protect children from abuse and neglect, and make health care coverage more affordable. His most recent book, *Two Presidents Are Better Than One: The Case for a Bipartisan Executive*, draws on his experience with partisan conflict as an elected official and his expertise in constitutional law to discuss reforms that would address the country's high levels of political polarization.

A graduate of Harvard Medical School and Harvard Law School, Dr. O is the author of Matters of Life and Death, co-author of Health Care Law and Ethics, and co-editor of The Oxford Handbook of Comparative Health Law. He has published numerous articles and essays on a wide range of topics, including Supreme Court reform, health care reform, physician aid in dying, reproductive decisions, affirmative action, and presidential power.

Dr. O's work has appeared in leading professional journals, such as the New England Journal of Medicine and the Journal of the American Medical Association (JAMA), as well as in the New York Times, Time, USA Today, CNN Opinion, and the Chicago Tribune. In addition to his academic experience, Dr. O brings important hands-on experience. He previously directed the American Medical Association's Division of Medical Ethics, where he drafted the AMA's first patient's bill of rights and many other guidelines relied upon by courts and government agencies, and he has practiced both law and medicine.

The three provisions of the U.S. Constitution, Full Faith and Credit Clause, the Privileges and Immunities Clause and the Equal Protection Clause have been presenting problems of understanding for lawyers and jurists since about the time the Constitution was drafted. They apply to so many different factual

situations that they defy a cogent description or definition. To solve this dilemma Professor Emeritus Richard H.W. Maloy, in his usual adroit manner, has stated verbatim five Uniform Acts and analyzed almost 700 cases in which courts have resolved issues concerning the provisions under examination. This lexicon (word book) has been constructed with the assistance of three brilliant people —two lawyers and a sagacious layman, as well as the scholarly tome "Making Our Democracy Work," written by U.S. Supreme Court Associate Justice Stephen G. Breyer - to whom this book has been dedicated. Only with an understanding of the cases considering the clauses and the observations of a knowledgeable jurist can an understanding of the Constitutional provisions be gained. They cannot be succinctly described. The cases are presented in short understandable wording, with an in-depth presentation of a few of the more complicated ones.


This book has not only been written for lawyers, but also for those many laymen who have expressed to the author an interest in those often considered, but seldom completely understood, terms so often used in American jurisprudence.

Communication Tips

Six Tips for Clear Writing

Many people read professional texts, emails, or documents only grudgingly. Often that is because of the style of writing, e.g., long sentences, loads of jargon and abstract language.

These six suggestions and examples should help you write texts, emails, and letters that are easy to understand.

- I. Use the active voice when possible.
- 2. Don't turn verbs into nouns.
- Introduce technical terms but avoid unnecessary jargon.
- 4. Be concrete and specific.
- 5. Cut out waffle and avoid wordiness.
- 6. Shorten and structure your sentences.

None of these six tips are set in stone. Rather, these are rules of thumb, meant to help make your communications understandable.

It isn't easy to write clearly about complex topics but it is worth making the effort.

Checklists



Most legal secretaries, legal assistants, and paralegals are familiar with checklists for court filings and other multi-step aspects of their practices. It's the only way to stay sane—

especially if they are new to the practice field or working for a new (to them) attorney who likes things done in a particular sequence.

You may be interested to learn the distinction between two types of checklists: Read-Do and Do-Confirm.

A Read-Do checklist might be prepared in advance for several potential possibilities. You check off the tasks as you do them, like following a new cooking recipe. A Read-Do list may be geared towards a specific task such as filing an appellate brief or helping a new employee understand what they should be doing and in what order and helping them remember key steps in unusual or unplanned scenarios. So, for example, if a plane develops a particular type of rare fault, such as an engine failure, a Read-Do checklist could be pulled out for that scenario. The pilot and crew can use it to make the most of others' past experiences and failures. Even with training, given the situation's relative rarity, and especially if a serious situation might interfere with normal thinking, a Read-Do checklist helps steer the crew to safe outcomes without relying solely on training and memory. The calm security and simplicity of steps of a checklist can be just what's needed.

A **Do-Confirm** checklist is more of an aid to memory to make sure nothing gets missed. It's a safety net to catching lapses in memory. In principle, we know what to do, so we run through those steps from experience and memory and use the Do-Confirm checklist at a designated pause point to ensure we didn't miss anything.

Because a simple checklist can never account for unexpected occurrence complex every environments—for example, litigation practices, healthcare, aviation, building a skyscraper, or software projects—both checklist types can benefit from items that require a communication step. An item can just be to ensure that all those with the relevant knowledge have discussed things. It's a simple and powerful way to improve outcomes across a wide range of unexpected scenarios.



I just finished a new series by Michele Brouder set in the fictious town of Hideaway Bay. Each novel in this 7-book series covers multiple generations of women. The first book is Coming Home to Hideaway Bay. These engaging novels are quick reads and you can find them at Walmart, Barnes and Noble, and on Amazon in Kindle or Audible format.



So Many Books and So Little Time

How do you choose a book to read? By Genre? Title? Author?

By Genre. I love historical fiction, mystery, thrillers, fantasy, westerns, family sagas, and biographies. I prefer long books (800—1,000 pages) that I can sink my teeth into, or a series of books that follow the same characters.

By Title. I once bought a book because I was intrigued by the title when sitting across the aisle from someone on a plane who was reading it:

The Craggy Hole in My Heart and the Cat Who Fixed It by Geneen Roth is a tender memoir about the author's life with her beloved father, Bernard, and a remarkable twenty-pound cat named Mister Blanche. It's often hilarious and insightful.

And I'm currently reading <u>The Seven Husbands of Evelyn Hugo</u> by Taylor Jenkins Reid which I found by chance on Libby, the free public library app where you can enjoy e-books, digital audiobooks, and magazines. According to Reid, <u>Evelyn</u> is

loosely based in part on actresses Elizabeth Taylor, who was married eight times to seven different men, and Ava Gardner, who revealed the secrets of her life to a journalist who published a book of their conversations. Evelyn is told in first person from the journalist's point of view and I was engaged from page one by the author's style of writing.

By Author. My local neighborhood book club selection one month was <u>Still Life</u> by Louise Penny. I enjoyed the quirky characters in this cozy mystery and subsequently have read seven more books in the Inspector Gamache series (18 books have been published to date with a 19th due out in October 2024). Each book solves a separate mystery while advancing the main characters' story lines in a broader mystery.

Nearly everyone has heard of the <u>Outlander</u> and <u>Harry</u> <u>Potter</u> series. Here is one of my favorites you may not be familiar with:

The **Farseer Trilogy** by Robin Hobb is an epic fantasy set in the fictional realm of the Six Duchies. It tells the story of FitzChivalry Farseer (Fitz), the illegitimate son of a prince whom we meet at the get go when he is six years old after he's been taken from his mother to live in the castle. Fitz possesses two forms of magic: a telepathic skill that runs in the royal line and a socially forbidden talent that enables bonding with animals.

The story is structured as a quest (with Arthurian motifs) and is narrated from Fitz's retrospective. The novel's primary society resembles medieval Europe in its technology, but has greater gender equality.

The Farseer Trilogy is the first of five integrated series set in the "Realm of the Elderlings": The Liveship Traders trilogy, the Tawney Man trilogy, the Rain Wild Chronicles, and the Fitz and the Fool trilogy.

I was captivated by all of the novels and satisfied at the conclusion in the Fitz and the Fool trilogy.

Another series that has captured my attention is the **Temeraire** series by Naomi Novik. It is a series of nine alternate history fantasy novels which follow the adventures of Captain William Laurence and his dragon, Temeraire, and reimagine events of the Napoleonic Wars with "an air force of dragons, manned by crews of aviators." There are nine books in this award-winning series.

Chapter & News

NALS Code of Ethics & Professional Responsibility

Members of NALS are bound by the objectives of this association and the standards of conduct required of the legal profession. Every member shall:

- Encourage respect for the law and administration of justice
- Observe rules governing privileged communications and confidential information
- Promote and exemplify high standards of loyalty, cooperation, and courtesy
- Perform all duties of the profession with integrity and competence
- Pursue a high order of professional attainment

Integrity and high standards of conduct are fundamental to the success of our professional association. This Code is promulgated by NALS and accepted by its members to accomplish these ends.

Canon I. Members of this association shall maintain a high degree of competency and integrity through continuing education to better assist the legal profession in fulfilling its duty to provide quality legal services to the public.

Canon 2. Members of this association shall maintain a high standard of ethical conduct and shall contribute to the integrity of the association and the legal profession.

Canon 3. Members of this association shall avoid a conflict of interest pertaining to a client matter.

Canon 4. Members of this association shall preserve and protect the confidences and privileged communications of a client.

Canon 5. Members of this association shall exercise care in using independent professional judgment and in determining the extent to which a client may be assisted without the presence of a lawyer and shall not act in matters involving professional legal judgment.

Canon 6. Members of this association shall not solicit legal business on behalf of a lawyer.


Canon 7. Members of this association, unless permitted by law, shall not perform legal functions except under the direct

supervision of a lawyer and shall not advertise or contract with members of the general public for the performance of paralegal functions.

Canon 8. Members of this association, unless permitted by law, shall not perform any of the duties restricted to lawyers or do things which lawyers themselves may not do and shall assist in preventing the unauthorized practice of law.

Canon 9. Members of this association not licensed to practice law shall not engage in the practice of law as defined by statutes or court decisions.

Canon 10. Members of this association shall do all other things incidental, necessary, or expedient to enhance professional responsibility and participation in the administration of justice and public service in cooperation with the legal profession.
