Peacekeeping Efforts in the South Sudan, the World's Newest Country



Judge Larry Sage was involuntarily inducted into the U.S. Army from the University of California Hastings College of the Law. He served more

than three years on active duty and, after transferring to the National Guard and returning to law school, served 25 more years. He retired as an infantry colonel from the U.S. Army Reserves. After Nevada judicial retirement, he supported Operation Enduring Freedom as an International Security Assistance Force Civilian Rule of Advisor for three years in Afghanistan, and recently returned from a year as an Intergovernmental Authority of Development (IGAD) peace monitor/legal advisor in South Sudan.

Judge Sage will share with us his insights and observations on South Sudan.

What is Power Under the Rule of Law?

Under the rule of law, power is the sovereign will of the people expressed as non-arbitrary laws that—theoretically, if not perfectly in practice— apply to everyone equally. This sovereign power also limits the exercise of governmental power so that it does not exceed the authority granted to it by the people.

There are two parts to this that are downright revolutionary. The first is the fact that the *people* are sovereign—not some divine-right monarch, or some combination of kings, lords, and commons. The people set the terms of how they will be governed in written constitutions. The second is that the people limit the exercise of power by their government through laws that are not capricious or arbitrary, and that apply uniformly, even to those leaders and representatives

who enact and enforce the people's law. Together these two innovations in political science provide a profound blueprint for self-government: the people are in charge, they are the fountain of authority from which the rules are made, and the rules apply to everyone.

The United States of America did not directly import this particular blueprint for power from Great Britain, though British constitutionalism indispensable to our thinking on the matter. King George III inherited a monarchy limited by constitutional revolution, the Glorious Revolution of 1688/89, which shifted the locus of sovereignty in Britain: the king was no longer the divine-right, absolute, arbitrary, fountain of law and justice of the past, but instead, Parliament—the House of Commons and the House of Lords-when working in concert with the king, constituted the ultimate authority in Great Britain and its empire. This revolution in constitutionalism made us North-American colonists incredibly proud to be liberty-loving Englishmen and women, until, of course, taxes, declarations of parliamentary will, quartering of troops in private homes, and tea parties changed our minds.

But if we did not have the benefit of the legacy of the Glorious Revolution—locating sovereignty in a body representing all the people in the realm, and linking that to Parliament's lawmaking function—we would not have been as well situated to make the intellectual leap to we, the people, are sovereign. It wasn't easy to put this popular sovereignty into practice; it took a great deal of experimenting during the 1770s and 1780s to figure out just how to implement this quite radical notion. And yet, the combination of historical research and hindsight, paired with innovative experimentation across the states, the framers of both state constitutions and the US Constitution managed to

create and execute an enduring framework whereby we, the people, are in charge.

And thus our American system: the people are sovereign-not your president, your member of Congress, governor, vour or vour state You-we-the people wield the representative. ultimate power to make law, to make the rules that are meant to apply to all, equally, and to ensure that we all live under, not above or apart from, those rules. This innovation in political thought, and its implementation in constitutional government, is an American marvel, and in its profundity, is truly extraordinary.

In 1969, Peggy Lee had a hit song titled "Is that All There is?" Is obtaining your CLP, or PLS, or PP all there is?

Continuing legal education is imperative in a changing legal environment. Changes and updates to laws, rules, technology, websites, and phones happen regularly. Have you updated your certifications? Consider obtaining a specialty certificate to show your employer you have gone beyond what's expected. Specialty certificates are available in:

Administrative Law E-Discovery Juvenile Law

Appellate Law Elder Law Law Office Management

Bankruptcy Law Employment Law Personal Injury Law

Business Law Estate Planning/Probate Real Estate Law

Civil Litigation Family Law Time Management

Contract Law Immigration Law

Corporate Law Intellectual Property

Any certified Professional Paralegal (PP), Professional Legal Secretary (PLS), or Certified Legal Professional (CLP) may earn a Specialty Certificate after obtaining 50 CLE credit hours in one or more areas of substantive law within a five-year validity period. Specialty Certificates will be valid for 5 years, after which time, a new application must be submitted in order to maintain a valid Specialty Certificate. After earning the requisite CLE credits, the legal professional may highlight their achievement by adding the "SC" as a post nominal designation. For example, John Doe, PP, CLP-SC or Jane Doe, PP, CLP, ALP-SC, Administrative Law. The CLE hours used to recertify your PP, PLS, or CLP designation can be applied to your Specialty Certificate. However, all 50 CLE credit hours must be dedicated to the same area of law. You may apply for multiple Specialty Certificates.

How Do I Obtain My Specialty Certificate?

You may participate in educational activities to earn continuing legal education (CLE) credit hours toward your specialty certificate. Be sure to obtain certificates of completion or other documentation confirming participation in educational activities. You'll need to attach additional information to documentation as needed. These educational activities consist of the following:

Attendance at Seminars/Workshops/Webinars: You may earn CLE hours by attending conferences, seminars, workshops, chapter educational programs, webinars, etc. on topics related to the specialty area in which you are receiving your certificate. Events must be a minimum length of 30 minutes. Copies of certificates of attendance or other documentation

confirming participation in the program are to be submitted with the completed application packet. Applicants should retain originals. Included in this module is credit for watching videos or listening to audio on relevant topics. Except for topics related to the specialty, credit is not available for personal development and/or motivational programs. To request points for watching a video or listening to audio, complete Section A of the Specialty Certificate Application.


Seminars/Workshops Taught: You may earn CLE hours by teaching at conferences, seminars, workshops, webinars, chapter educational programs, etc. on topics related to the specialty area in which you are receiving your certificate. Seminars must be a minimum length of 30 minutes. One (1) teaching hour equals four (4) CLE credits, which includes credit for preparation and presentation time. Except for topics relating to the specialty area in which you are receiving your certificate, credit is not available for personal development and/or motivational programs. To request CLE for teaching educational programs, complete Section B of the Specialty Certificate Application. A copy of the seminar brochure verifying the applicant as a speaker or other documentation confirming applicant's participation in the program is to be submitted with the online application. Applicants should retain originals, as the NALS Resource Center discards submitted documents upon approval of the application.

Authoring Articles and Publications: Section C of the Specialty Certificate Application should be completed and submitted, along with documentation verifying participation in authoring of articles or publications. This covers authoring

articles regarding topics pertaining to your specialty track. Five (5) CLE hours are awarded for substantive articles.

Successful Completion of Postsecondary Education Courses: This module covers successful completion (Grade C or better) of relevant courses (courses related to the specialty tracks designated by NALS) at an accredited institution of higher education. Higher education institutions are generally organized into semesters (14 to 16 weeks in length providing "semester hours" or 10 to 12 weeks in length providing "quarter hours"). CLE credit hours are calculated on the basis of 15 CLE credits per semester hour and 10 CLE credits per quarter hour. Copies of transcripts or grade reports and official course descriptions are to be submitted with the completed renewal packet. Applicants should retain originals, as the NALS Resource Center discards submitted documents upon approval the application.



NALS Code of Ethics & Professional Responsibility

Members of NALS are bound by the objectives of this association and the standards of conduct required of the legal profession. Every member shall:

- Encourage respect for the law and administration of justice
- Observe rules governing privileged communications and confidential information
- Promote and exemplify high standards of loyalty, cooperation, and courtesy
- Perform all duties of the profession with integrity and competence
- Pursue a high order of professional attainment

Integrity and high standards of conduct are fundamental to the success of our professional association. This Code is promulgated by NALS and accepted by its members to accomplish these ends.

Canon 1. Members of this association shall maintain a high degree of competency and integrity through continuing education to better assist the legal profession in fulfilling its duty to provide quality legal services to the public.

Canon 2. Members of this association shall maintain a high standard of ethical conduct and shall contribute to the integrity of the association and the legal profession.

Canon 3. Members of this association shall avoid a conflict of interest pertaining to a client matter.

Canon 4. Members of this association shall preserve and protect the confidences and privileged communications of a client. **Canon 5.** Members of this association shall exercise care in using independent professional judgment and in determining the extent to which a client may be assisted without the presence of a lawyer and shall not act in matters involving professional legal judgment.

Canon 6. Members of this association shall not solicit legal business on behalf of a lawyer.

Canon 7. Members of this association, unless permitted by law, shall not perform legal functions except under the direct supervision of a lawyer and shall not advertise or contract with members of the general public for the performance of paralegal functions.

Canon 8. Members of this association, unless permitted by law, shall not perform any of the duties restricted to lawyers or do things which lawyers themselves may not do and shall assist in preventing the unauthorized practice of law.

Canon 9. Members of this association not licensed to practice law shall not engage in the practice of law as defined by statutes or court decisions.

Canon 10. Members of this association shall do all other things incidental, necessary, or expedient to enhance professional responsibility and participation in the administration of justice and public service in cooperation with the legal profession.




