Continuing Legal Education

As much as you think you already know, you have a lot to learn. New technology, changing rules, younger bosses with new ways of thinking or preferences.

Many of us learned new things this year: working remotely, Zoom or Google Meet with family and friends or co-workers, home school our children or grandchildren—or at the very least, assist with online classroom assignments.

COVID-19 precipitated a demand for knowledge outside our comfort zone in the office as well. Even the least technical person can suddenly be tasked with turning their office into a wireless showcase as a friend told me. Overnight they had to learn a new language in order to purchase the right system and to interview potential vendors and tradesmen to install and support the equipment acquired.

The hallmark of a competent legal professional is the thirst for knowledge. Don't be content merely to know enough to get by. Broaden your knowledge base. Listen to legal podcasts, subscribe to legal blogs, take advantage of training opportunities through NALS or other providers.

Some of the best legal podcasts and episodes in 2020 were:

- <u>Lawyerist</u>—Podcast Episode #147 regarding accessible justice and how designing courts, law firms, and the attorney-client relationship for people with disabilities can increase access to justice for everyone.
- <u>LawNext</u>—conversations in each weekly episode range from blockchain, new legal

tech products and services, and the future of law and legal practice. It's a great podcast for those interested in legal innovation or who want to keep up-to-date on legal tech trends and development.

- <u>Legal Toolkit</u>—a monthly podcast on law practice management featuring interviews with top lawyers and professionals to discuss the latest in legal trends, tools, and tips for building a better law practice.
- <u>Lawyers Gone Ethical</u>—a weekly podcast for anyone that wants to stay up to date with the constantly changing ethical rules of law.
- The Paralegal Voice—a monthly podcast hosted by Carl Morrison provides in-depth and fascinating commentary on hot button issues, as well as helpful career advice.
- <u>Serial</u>—The first two seasons dive deep into infamous legal cases. The hosts examine cases from angles no one else ever thought of, something paralegals thrive on when assisting their attorneys.

Becoming aware of trends in your profession and practice area is vital but before you even begin to implement the modifications these trends suggest, you first have to be willing to accept change. Be open to new ideas and be willing to discuss them with your attorneys.

NALS Code of Ethics & Professional Responsibility

Members of NALS are bound by the objectives of this association and the standards of conduct required of the legal profession. Every member shall:

- Encourage respect for the law and administration of
- Observe rules governing privileged communications and confidential information
- Promote and exemplify high standards of loyalty, cooperation, and courtesy
- Perform all duties of the profession with integrity and competence
- Pursue a high order of professional attainment

Integrity and high standards of conduct are fundamental to the success of our professional association. This Code is promulgated by NALS and accepted by its members to accomplish these ends.

Canon 1. Members of this association shall maintain a high degree of competency and integrity through continuing education to better assist the legal profession in fulfilling its duty to provide quality legal services to the public.

Canon 2. Members of this association shall maintain a high standard of ethical conduct and shall contribute to the integrity of the association and the legal profession.

Canon 3. Members of this association shall avoid a conflict of interest pertaining to a client matter.

Canon 4. Members of this association shall preserve and protect the confidences and privileged communications of a client.

Canon 5. Members of this association shall exercise care in using independent professional judgment and in determining the extent to which a client may be assisted without the presence of a lawyer and shall not act in matters involving professional legal judgment.

Canon 6. Members of this association shall not solicit legal business on behalf of a lawyer.

Canon 7. Members of this association, unless permitted by law, shall not perform legal functions except under the direct supervision of a lawyer and shall not advertise or contract with members of the general public for the performance of paralegal

Canon 8. Members of this association, unless permitted by law, shall not perform any of the duties restricted to lawyers or do things which lawyers themselves may not do and shall assist in preventing the unauthorized practice of law.

Canon 9. Members of this association not licensed to practice law shall not engage in the practice of law as defined by statutes or court decisions.

Canon 10. Members of this association shall do all other things incidental, necessary, or expedient to enhance professional responsibility and participation in the administration of justice and public service in cooperation with the legal profession.


