#### What do School Lawyers Do?


School lawyers are employed by school boards to represent their school districts in legal matters. These lawyers need to wear many hats. Their job duties include offering advice on legal and policy matters, researching legal issues, and representing the school district in litigation matters.

School boards and district staff must deal with legal issues daily. A school board attorney helps district officials to follow the web of state and federal regulations affecting schools, and to avoid costly litigation. When litigation is necessary, a school attorney advocates for the school board before courts and administrative bodies.

Good school lawyers use independent judgment and avoid conflicts of interest. They are adept at preventive law and they focus on controlling legal issues whenever possible and anticipating problems and legal solutions before litigation happens. They are up-to-date on current school law trends and recent court decisions.

If the sample form is from a court other than the one in which you are filing, you MUST change the form to reflect the court in which you are filing. You MUST ALSO contact the <u>clerk of the court</u> where your item will be filed to make sure you meet all <u>formatting</u>, <u>content and procedural requirements</u>.

#### **Time for a Change?**

No, we're not talking about Daylight Savings time. Maybe you have been thinking you're stuck in a dead-end job and that it is time for a career change but are holding back because you have a lot of blood, sweat, and tears invested in your current position and change is hard.

Maybe you love your boss(es), but dread the routine. Maybe you can barely tolerate your boss's habits, attitude, or flagrant disrespect.

If you're not happy in your current situation, what are you going to do about it?

#### Assess

- What do you like best and least about your current position?
- What are your strengths? Weaknesses?
- If it's the daily routine that is dragging you down, what would it take to re-energize you?

#### Research

- Explore lateral career options. A change of practice area may be just the thing to reawaken your passion. Or moving from a solo practitioner office where you had responsibility for everything (and never felt you could take a day off without coming back to a disaster) to a firm with departments (librarians, production center, office services, etc.) can help you refocus on the legal work you most enjoy.
- Look at different employer options. Investigate
  career opportunities in corporations. Many of
  them have in-house legal departments or offer
  positions involving project management,
  or human resources where your people and
  team management skills would be of value.
  Many corporate positions come with a higher
  salary (and often stock options) than those
  offered at law firms.

#### Create a Plan

Coaching sessions help you explore your career strengths and develop a plan for moving in a new direction.

If you have been working in the legal field for most of your career, it might be helpful to take a career assessment test at your local college. Don't be fooled by the word "test" because there are no right or wrong answers. The goal isn't to be "right" but to be accurate and true to yourself.

A career coach can often provide a greater degree of insight, analysis, honesty, and encouragement than you can on your own. A coach can evaluate your work history to help you better define your skills and abilities. They can help to build your confidence to overcome limitations you may have put on yourself.

Be aware that some career alternatives might necessitate additional training or education when you decide to make the career transition from paralegal to another field. Find out what those are before you make any decisions. For example, if you are considering a teaching job, you would have more options available to you if you had a master's degree. If you were interested in a sales position, you might want to explore some courses on sales techniques. You would also want to talk to as many legal support vendors as possible to learn what it takes to be successful in a sales position.

Make sure you understand the pros and cons of any role you are considering transitioning to.

#### **NALS Code of Ethics & Professional Responsibility**

Members of NALS are bound by the objectives of this association and the standards of conduct required of the legal profession. Every member shall:

- Encourage respect for the law and administration of justice
- Observe rules governing privileged communications and confidential information
- Promote and exemplify high standards of loyalty, cooperation, and courtesy
- Perform all duties of the profession with integrity and competence
- Pursue a high order of professional attainment

Integrity and high standards of conduct are fundamental to the success of our professional association. This Code is promulgated by NALS and accepted by its members to accomplish these ends.

**Canon 1.** Members of this association shall maintain a high degree of competency and integrity through continuing education to better assist the legal profession in fulfilling its duty to provide quality legal services to the public.

**Canon 2.** Members of this association shall maintain a high standard of ethical conduct and shall contribute to the integrity of the association and the legal profession.

**Canon 3.** Members of this association shall avoid a conflict of interest pertaining to a client matter.

**Canon 4.** Members of this association shall preserve and protect the confidences and privileged communications of a client. **Canon 5.** Members of this association shall exercise care in

using independent professional judgment and in determining the extent to which a client may be assisted without the presence of a lawyer and shall not act in matters involving professional legal judgment.

**Canon 6.** Members of this association shall not solicit legal business on behalf of a lawyer.

**Canon 7.** Members of this association, unless permitted by law, shall not perform legal functions except under the direct supervision of a lawyer and shall not advertise or contract with members of the general public for the performance of paralegal functions.

**Canon 8.** Members of this association, unless permitted by law, shall not perform any of the duties restricted to lawyers or do things which lawyers themselves may not do and shall assist in preventing the unauthorized practice of law.

**Canon 9.** Members of this association not licensed to practice law shall not engage in the practice of law as defined by statutes or court decisions.

**Canon 10.** Members of this association shall do all other things incidental, necessary, or expedient to enhance professional responsibility and participation in the administration of justice and public service in cooperation with the legal profession.
