

FLASH FLOODS DEVASTATE TEXAS HILL COUNTRY - DEATH TOLLS AND MISSING NUMBERS CONTINUE TO RISE







July 4th brought unprecedented flash flooding to the beautiful Texas Hill Country with numbers of fatalities and missing rising daily. The latest accounts are 132 dead and more than 150 missing and unaccounted for.

The flooding occurred during the early morning hours while most residents were asleep. Warnings were issued but he tumultuous pace of the waters left little time to find shelter and safety.

The flooding was triggered by heavy rains that caused the Guadalupe River to rise nearly 30 feet in less than an hour.

As efforts to recover and account for the missing go on, heavy rains continue to thwart efforts.





Among the hardest hit areas from the flooding was Kerr County, specifically a well-known girl's camp called Camp Mystic, located on the banks of the Guadalupe River. The tragedy claimed 27 campers and counselors.

Other camps are also located along the river, including Camp La Junta, where 2 young brothers were among the campers who escaped the floods.

Camp La Junta and another nearby camp, Camp Waldemar, posted on social media that all their campers and staff were safe.





IF DISASTER FORCES YOU TO FLEE, WILL. YOU BE PREPARED?

Here are some tips for your safety and wellbeing if you ever need to get out of your home quickly. These tips are important for everyone, regardless of where you live; however, they are particularly essential for those living in sensitive areas where hurricanes and tornados are frequent. STEP #1 - Personal documents. Take original or copies of your Social Security cards, passports, birth certificates, marriage and divorce documentation, wills, and other estate planning papers.

STEP #2 - Home inventory. Make a video or take photographs of every room in your home. Include your closets and drawers. Document all your possessions.



STEP #3 - Cash On Hand. Make sure that you have some cash available for times when extensive power loss renders ATM's and credit card readers inoperable.

STEP #4 - Medications and First Aid. Have a back-up supply of your medications ready in case you run out and have trouble refilling your prescriptions in time. Keep a simple first aid kit including pain medication like aspirin and Tylenol, sanitizer wipes, band-aids and antiseptic.

Step #5 - Insurance Policies and Account Information. Have your insurance company's contact numbers and your policy numbers available. Simply make copies of the declaration pages and that should be enough to get you started. Keep your bank accounts and any safe deposit box information handy so you may access it if needed.

Step #6 - Phone Numbers and Contacts. Make a list of phone numbers and other contacts as backup in case power outages. If your cell phones aren't properly charged you won't be able to access this information.

BIG BEAUTIFUL BILL SPARKS INTEREST OF FIREFIGHTERS AND OTHER UNIONS

On Independence Day 2025, President Trump's One Big Beautiful Bill was signed into law. The bill passed by a vote of 218 - 214 in the House of Representatives. **whitehouse.gov** writes: The bill combines the largest tax cuts in history with landmark investments in America's future and defense.

The bill is an extensive piece of legislation which covers many areas of our lives from health care to farming, to Social Security and more. While the pros and cons were hotly debated throughout the creation and ultimate passing of the bill, many high-profile unions believe it will be a great win for our citizens.

Among those is the International Association of Fire Fighters. Prior to the July 4th official passing, IAFF General President Edward Kelly said, "We believe that this bill is going to impact the lives of working families all throughout the United States, in particular our seniors, with tax breaks on Social Security as well as our hardworking firefighters throughout the United States that are putting in excess overtime."

IAFF Political Program Coordinator, Chris Bartley says the "plan to stop taxing overtime would be a great benefit to our firefighters, where they can keep the money they actually earned."

The National Police Union also is on board in support of the bill. National Fraternal Order of Police President Patrick Yoes said that the "one big, beautiful bill act is more than legislation - it is a promise kept to the public safety officers across the country and a bold step toward an economy that respects, rewards, and uplifts the people who keep it safe." The FOP represents 377,000 members.







FDNY RESPONDS TO 2 INCIDENCES OF EXCESSIVE PROPANE STORAGE TANKS

On Tuesday night, 7/15/25, the **NYPD** was responding to a vehicle collision involving a white minivan on42nd St. and 10th Ave. The driver of the van attempted to dispose of his keys, claiming he could not open the van. Officers requested FDNY assistance after noticing a strong smell of gasoline and propane

Members from E65 forced entry into the van and

tanks in the back

of the van.

FDNY Hazmat Units removed 76 20-pound propane cylinders, 15 5-gallon fuel containers (for a total of 75 gallons of gasoline), and 10 gallons of diesel.

The driver was charged with reckless endangerment and was in violation of multiple fire codes. The department did not provide any details as to why the man had so many tanks in his van. The Manhattan District Attorney's Office is not handling the case.

if you see something...say something!

On Friday, 7/19/25, just a few days after a large seizure of illegally stored hazardous materials were found, the FDNY received reports of a van storing a large amount of propane in front of 72 Spring Street in lower Manhattan. FDNY Fire marshals arrested Marcel Djiba after 82 20-poung propane cylinders and 12 portable gasoline containers were discovered inside the van.

During questioning, Mr. Djiba stated he was delivering propane to food trucks throughout New York City on behalf of a company. Djiba was previously arrested by Fire Marshals in 2010 for a similar incident involving the illegal transport of hazardous materials.

This case underscores the FDNY's continued efforts to identify and eliminate illegal and dangerous propane distribution operations throughout the city, particularly in high-traffic areas. Thanks to the swift action of the FDNY members, a tragedy was avoided.


ELDER FRAUD IS SKYROCKETING....WHAT YOU NEED TO KNOW

IN A RECENT REPORT, THE FBI CITED a marked increase in crimes targeting seniors, with financial scams taking the forefront. Last year the FBI received more than 40,000 complaints with \$5.8 billion reported stolen.

These scams often come in random telephone calls asking for your personal information, maybe threatening you about supposed unpaid fines or road tolls, and even sending bogus warnings of hackers on our various accounts.

REMEMBER: THINK BEFORE YOU EVER RESPOND TO UNSOLICITED PHONE CALLS, TEXTS, OR EMAIL MESSAGES. UNDERSTAND THAT THERE ARE BAD FOLKS OUT THERE JUST WAITING TO PREY ON YOU. YOU KNOW YOUR SITUATION BETTER THAN ANYONE. IF SOMEONE CALLS ABOUT UNPAID FEES, DON'T PANIC. HANG UP OR END THE CONTACT. ONCE THEY GET A GRIP ON YOU, YOU WILL HAVE VERY LITTLE RECOURSE TO EVER GET BACK THAT HAS BEEN STOLEN.

5 WAYS TO THWART A TEXT SCAM - Ever get something like this? "Your UPS package is undeliverable at the address on the box. Click on the link below to confirm the address."

- **1.** Filter your unknown phone numbers. Set up your phone to block unknown numbers.
- 2. Read the message carefully and slowly. If the text urges quick action, it is most likely a scam.
- 3. Don't respond. Ignore texts from unknown numbers. Legitimate callers will know how to contact you.
- **4.** Verify numbers. If a text asks you to call a bank or other company, look up the number. If you use the number in a scam text, they've got you!
- **5.** Beware of red flags. Don't click on any links, or call any number. If they mention "crypto" hang up...delete and block the call.

People are more trusting of text messages these days, with most of us getting messages from friends and family. We are used to responding to them promptly as opposed to emails which are often quickly deleted. Be smart and stay sharp. When in doubt, trust your instincts and BLOCK AND DELETE.
