• Treasurer's Monthly Report

Reviewed financial report and projected expense reports – expanded to include liability ins. Motion to approve by Mark and seconded by Sue

• Neighborhood Clean-up grant update

Application submitted-identified goals of expanding scope of clean up and request for funding for supplies.

• Historical Homes update (5 new homes)

Five new homes have been added to the tour for a total of 9 homes. Sue is working on background research for another 5 properties. Athol noted a correction is needed to the sign that is posted in front of her house. The cost for producing each sign is \$40.

• City Update: Mikayla Taylor (10 min.)

- Mikayla reported that the city is anticipating a \$60 million deficit and is sponsoring community meetings to seek input from the public. The next meeting is to be held March 14th at the Clunie Community Center. Input is also being sought through an online survey which will be distributed to FOCM membership.
- Sue asked whether there were plans by the city to bring out claw to collect storm debris Mikayla will research and respond to FOCM email.

• Bi-monthly Police Report (10 min.) – Lieutenant Justin Thompson

No serious crimes were reported this quarter. 1 residential burglary and 2 car break ins were reported.





There was a commercial burglary at Bike Shop on K Street and an arrest has been made. A Mardi Gras event was held on Saturday, March 9th– no problems/events occurred. Lt. Thompson was asked about the impact the budget deficit could have on the Police Department. He indicated that, at this point, layoffs are not anticipated. There are still unfilled positions that are currently being covered by officers on overtime and the intent is still to fill those vacancies.

Jack asked about the large groups of bike cyclists in midtown that are taking over streets and scaring pedestrians. Lt. Thompson indicated that cyclists are expected to follow the same rules of the road as vehicles and can be ticketed if infractions are observed.

Alex explained the concept and goals as follows:
