Board of Directors Meeting Minutes

- Call to order of the Board of Directors meeting at 6:35 pm, George Prat, Lee Ivey, Jr., Kristi DeNardo and Brendan Doran were present. Teresa Ricard was absent.
- Review/Approval of the Minutes from February 24, 2021: Lee Ivey, Jr. read the
 minutes aloud for those present. George Prat made a motion to approve the
 minutes as prepared, Kristi DeNardo seconded the motion, all in favor, motion
 carried.
- 3. Review/Approval of the Financials
 - a. February 28, 2021 the February financials were presented to the board for consideration. The operating account had \$306,438.67 as of February 28, 2021. The reserve accounts had \$233,954.93 as of February 28, 2021 and the outstanding AR was \$107,695.81. The association is \$22,294.62 under budget however there are some big projects coming up. Brendan Doran made a motion to approve the February 28, 2021 financials as presented. Lee Ivey seconded the motion, all in favor, motion carried.

- b. Road Condition: there are currently several potholes in the community,Fort Bend Road and Bridge will be making the repairs.

6. Committee Reports

- Landscaping: Diana Garcia gave the landscape update; she will be working closely with Superior LawnCare for the upcoming spring planting.
