

**Wyoming All Breeds Racing Association
Wyoming Bred Stallion Progeny Futurity
For Foals Born in 2018, With the Futurity to be run in 2020**

Rules & Regulations

The Wyoming Bred Stallion Progeny Futurity is restricted to all foals sired by participating stallions, outlined below, and are eligible to make payment into this futurity.

Sire Participation

1. All Wyoming Bred Accredited stallions are eligible for this program and must remain accredited to participate.
2. The owner of an eligible stallion must be a member of Wyoming All Breeds Racing Association (WABRA) at the time of nomination and each succeeding year to remain eligible.
3. Eligible stallions may be nominated by member owners by paying \$500 by June 15th, 2018, 2019, 2020, and etc.. There is a late payment period from June 16 - July 15 of a \$1000 after that there will be no exception.
4. Stallions will receive no awards unless bred to an Wyoming Bred Accredited bred mare.

Foal Nomination

Foals nominated for the 2020 Wyoming Bred Stallion Progeny Futurity must make following payments to the Nominating Secretary to remain eligible. The original nominator of the foal must be a member in good standing of the WABRA at the time of the nomination.

Wyoming All Breeds Racing Association

The 2020 Wyoming Bred Stallion Progeny Futurity is for all foals sired by participating stallions, foaled in 2018 and remaining eligible by making payments on or before due dates

1. The WABRA shall designate the time and place the Futurity will be run.
2. Purse distribution is as follows:
 - 10 Horse field
 - A. 40 or more entries,

Finals: (90%) 35-16-10-9-6-5-4. 9-4. 8-4. 7-6. 6.
Consolation: (10%) 45-25-15-10-5

B. 39 or less entries,

Finals: 35-16-10-9-6-5-4. 9-4. 8-4. 7-4. 6

No Consolation

C. If less than 10 horses enter the trails:

9 Horses 38-18-10-6. 5-5. 9-5. 8-5. 7-5. 6-4. 5

8 Horses 45-20-10-7-6-5-4-3

7 Horses 45-20-12-8-6-5-4

6 Horses 45-22-14-8-6-5

3. There shall be no "Also Eligible: list. If a horse which has qualified for the finals should scratch, the owner will receive last place money. If more than one horse should scratch, then these monies will be added together and divided equally among those scratching. Qualifying horses that are ruled not eligible by the WPMC for rules violations will not be entitled to purse money, that money will be divided among horses that are eligible to compete.

4. The rules governing the Annual Wyoming Bred Stallion Progeny Futurity shall be reviewed and approved on an annual basis with amendments being made periodically to adapt to the continually changing situations of the horse racing industry and for the benefit of the horsemen of Wyoming.
