# 2025 Wyoming Stallion Breeder's Futurity

### **Stallion Nomination Form**



#### **Rules & Regulations**

The Wyoming Stallion Breeder's Futurity is restricted to foals sired by participating stallions, outlined below, and are eligible to nominate in 2028 for this futurity.

#### **Sire Participation**

- 1. All Wyoming Accredited stallions are eligible for this program and must remain accredited to participate. The stallion must stand the entire breeding season in Wyoming and be accredited with the Wyoming Gaming Commission by January 1<sup>st</sup>, 2025 for the resulting 2026 foals to be eligible.
- 2. The owner of an eligible stallion must be a member of Wyoming All Breeds Racing Association (WABRA) at the time of nomination and each succeeding year to remain eligible.
- **3.** Eligible stallions may be nominated by member owners by paying \$500 by January 15<sup>th</sup>, 2025 for foals born in 2026, with the Futurity to be run in 2028. There is a late payment period from January 15<sup>th</sup>- February 15<sup>th</sup> of a \$1000, after February 15<sup>th</sup> no nominations will be accepted.
- **4.** Stallions will only receive WY Breeders awards monies from their accredited Wyoming Bred Racing Stock.

#### **Wyoming All Breeds Racing Association**

- 1. The WABRA shall designate the time and place the trials and Futurity will be run.
- 2. 75% of the \$500 nomination fee will go to the Futurity, 15% will go to the Derby and 10% will be added to the Maturity.
- 3. There shall be no "Also Eligible: list. If a horse which has qualified for the finals should scratch, the owner will receive last place money. If more than one horse should scratch, then these monies will be added together and divided equally among those scratching. Qualifying horses that are ruled not eligible by the Wyoming Gaming Commission for rules violations will not be entitled to purse money, that money will be divided among horses that are eligible to compete.
- 4. The rules governing the Annual Wyoming Stallion Breeder's Futurity shall be reviewed and approved on an annual basis with amendments being made periodically to adapt to the continually changing situations of the horse racing industry and for the benefit of the horsemen of Wyoming.
