Thank you for your interest in Dana's Dog Sitting and Boarding. I love giving each dog their own special attention and am committed to the well-being of your pet. I look forward to meeting you and your dog(s)!

## Guidelines:

- All dogs must be 12 weeks of age or older.
- All dogs 6 months or older must be spayed or neutered. Dana's Dogs is not liable for any injuries or damages that may occur, and the dog will be evaluated throughout their stay. Excessive mounting, indoor marking, aggression, and bullying are not allowed.
- All dogs must have up-to-date vaccinations. Owners must submit proof of the following: DLHPP (Distemper, Hepatitis, Leptospirosis, Parainfluenza, and Parvovirus), Rabies, and Bordetella – Written proof must be provided by a veterinarian.
- Flea and tick preventatives are required.
- All dogs must be in good health. Owners will certify their dog(s) are in good health and have not been ill with a communicable disease in the last 30 days. Dogs who have been ill within the last 30 days must have a veterinarian's certification of health. I verify that my pet(s) is without internal or external parasites including, but not limited to fleas, ticks, mites, ring worm, or other contagious conditions. If such conditions are found, I may be charged an additional sanitation fee (minimum \$40), my dog will be quarantined away from the regular kennel area, or I may need to make arrangements to pick up my dog immediately depending upon the conditions.

Boarders will get to be treated as one of our family, getting comfortable bedding and blankets, cuddles, and plenty of playtime.

Parents will receive pictures and updates of your pet during their stay. **Drop off and pick-up times are BY APPOINTMENT ONLY. Drop offs/pick-ups during regular business hours result in the full day boarding fee, any pickups after 7 pm will result in an extra \$15 late fee, adequate communication is required.** Any dog still within our care after 7:30 pm will be boarded an additional night and the owner will be charged for an additional stay. In the case of a cancellation, I understand I will be charged 50% of all days that I have reserved for my dog unless given 3 days' notice. \*Additional charges for holidays might apply\* I also understand I could be charged a damage or sanitation fee if applicable.

By signing this form, I agree that my pet(s) may be videotaped, photographed, and recorded. I further agree that my pet(s) may be used in any and all media and promotion advertising, sale, and publicizing of Dana's Dogs and its services.

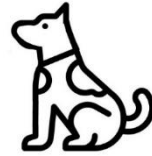
