Characteristics of a Good Candidate: Good interpersonal skills, relationship building and maintenance skills, de-escalation skills or ability, flexible thinker, case management skills as supports to families, community outreach abilities, and progress note documentation. Wraparound Facilitator must have significant community relationships, good relationships with law enforcement, and have the ability to work independently.

Job Description:

Conduct high fidelity team building, team meetings, and team facilitation within a family driven system of care framework for youth that have been charged or convicted of a misdemeanor or felony.

Provide intensive care coordination and case management to youth and their families as well as consultation to team members and others involved in the life youth that have been referred by Redeploy.

Conduct YASI assessments, screeners, assessment, and progress monitoring tools.

Recruit, train, and coordinate volunteers within the lives of youth to increase team members and positive adult relationships.

Provide ongoing and follow up case management which may include phone calls, follow up home visits, and linkage and referral to long-term supports if needed.

Create crisis management plans and conduct de-escalation for youth and families in crises, including afterhours. This may include providing reflective listening and utilization of the ALGEE from Youth Mental Health First Aid or other support protocols to youth and family members.

Provide awareness and consultation for understanding what has happened to a child and family and how to support youth in the judicial system and their families. Specific targets are law enforcement partners, volunteers, and community partners including those in multiple sectors.

Specifically target the community and system of care to be more trauma informed, sensitive and responsive to the target population and especially marginalized populations including cultural, racial, and ethnic minority groups.
