PRESENTATION TO COUNCIL: KARL EDGAR

Mr. Edgar was welcomed to the meeting to discuss the sewage connection at his property on Bridge St. Mr. Edgar is asking for the account to be closed, because the property is no longer usable and the house was torn down after the 2013 flood. Mayor Sweeney explained that the by-law states that vacant lots must pay 25% of the annual fee, and that there are other lots in the former Village in the same situation.

Council discussed the matter when Mr. Edgar left, and agreed that he should pay whatever is owing on the account now, but that they would be open to finding out if there are any options for him.

i) Nashwaak Valley ATV Club

Adam Russell was welcomed to the meeting to discuss the former Village of Stanley's incomplete ATV by-law and the required Highway Use Permit (HUP).

Council discussed the request and agreed that the route through the former Village should be from the Mick Rd., down the Park Hill trail behind the Agrena, out Centennial St., and onto Main/Bridge (Route 620) to the Ward Settlement Rd.
