COMMISSIONERS MEETING

November 13, 2025

The meeting was called to order at 7:33pm. Commissioners Tim Young and Bob Rohrick were present as well as Chief Fuller and Asst. Chief Foxworthy. Commissioner Gogolski had an excused absence. The meeting was also available virtually for any member of the public who would like to attend. The agenda was approved. The minutes from the last meeting were amended and approved. The treasurer and auditor reports were reviewed. The checking and payroll bank accounts were reviewed.

Respiratory illness update:

- RSV, COVID 19 and flu are still well below 1%.

Energy report including usage at Station 2:

- The energy uses for both stations are within normal ranges.

Naked Falls Hipcamp (NFH)/Public Comment:

- The Emergency Response Plan that the owner submitted, as required by the Conditional Use Permit (CUP), did not include all the required issues to be addressed.
- Included in the Plan were some errors, including that his property was in our district, which it is not.
- There is still no camp host at the site.

Western Skamania County Public Service Complex (WSCPSC):

- Chief Fuller sent the required letters to the Tribes and the Historic Preservation Society in order to receive the grant.
- They will get back to us with their findings by November 17th and the Chief will inform the Board when that happens.

WA State Ratings Bureau (WSRB):

- Jason Sanders, from the Ratings Bureau, is working on our rating and will schedule a tender credit demonstration when he is available.

State Audit:

- Chief Fuller and Secretary Cartan discussed the “best practices” as suggested by the State Auditors.

2026 Budget:

- Commissioner Young made a motion to approve the 2026 Budget as presented in the budget hearing; it was seconded by Commissioner Rohrick and the motion passed.
- Commissioner Young read the resolution 2025-02.
- Commissioner Young made a motion to adopt the resolution; it was seconded by Commissioner Rohrick and the motion passed.

Levy Certification:

- Commissioner Young made a motion to have the Levy Certification approved by the Commission Chair when Skamania Co. gets us the additional allowed due to increase of State Assessment number; it was seconded by Commissioner Rohrick and the motion passed.

Good of the Order: Chief Fuller suggested that we move the meeting time every month to 6pm and it was approved by all.

Vouchers totaling: \$73,178.24 were approved and signed by the Commission.

Payroll totaling \$4,560.51 was approved and signed by the Commission.

Meeting adjourned at 8:30pm by Commissioner Young.
