MEMBERSHIP TERMS & CONDITIONS AGREEMENT

Please read these Terms and Conditions carefully before completing registration.

This document constitutes a legally binding agreement between ALBANNA MARTIAL ARTS CENTER (hereinafter referred to as “the Center”) and the member or legal guardian (hereinafter referred to as “the Member”).

Registration, payment of fees, attendance of any training session, or use of any services provided by the Center shall constitute full, final, and legally binding acceptance of all terms herein, even if no physical signature is provided.

ARTICLE 1: NATURE OF MEMBERSHIP

- Membership is strictly personal and may not be transferred, assigned, sold, or shared with any other individual under any circumstances.
- Membership is non-transferable and non-freezable. Suspension, extension, or credit adjustments may only occur at the sole discretion of the Center.
- Enrollment constitutes a contractual commitment for the agreed membership duration.

ARTICLE 2: FEES & FINANCIAL POLICY

- All fees paid to the Center — including but not limited to membership fees, registration fees, testing fees, event fees, tournament fees, training camps, equipment purchases, and any other service-related payments — are final and strictly non-refundable under any circumstances and for any reason whatsoever, whether personal, medical, security-related, administrative, or force majeure.
- Absence, withdrawal, relocation, or personal circumstances shall not entitle the Member to any refund, credit, or compensation.
- Uniforms, gloves, and protective equipment are mandatory and are not included in the membership fee. The Member bears full responsibility for purchasing required equipment.
- The Center reserves the right to suspend membership immediately in case of unpaid dues without prior notice.

ARTICLE 3: PROMOTIONS & DISCOUNTED OFFERS

- When enrolling under a promotional or discounted offer, the amount paid shall be deemed consideration solely for the base paid months calculated at the standard original rate applicable at the time of registration.
- Any additional months or periods granted under the promotion shall be considered complimentary promotional benefits with no independent monetary value.
- In the event of any settlement calculation — if granted solely at the Center’s discretion — consumed months shall be calculated at the original non-discounted rate.
- Promotional offers cannot be combined.
- Promotions are time-limited and shall not be automatically extended.

ARTICLE 4: BELT TESTING & RANK PROMOTION

- Belt examinations are mandatory for children and female members.
- The Member or legal guardian is obligated to pay testing fees immediately upon announcement without objection or delay.
- Testing fees are non-refundable.

ARTICLE 5: ATTENDANCE & PARENT POLICY

- Parents and guardians are strictly prohibited from remaining inside the training area during sessions.
- Children must be fully independent in using restroom facilities as a condition of enrollment.
- All Members must fully comply with all policies, regulations, and operational rules of the Center throughout the membership period.

ARTICLE 6: PROGRAM MODIFICATIONS

- The Center reserves the right to modify training schedules, session timings, instructors, programs, and class structures at its discretion without creating any entitlement to refund or compensation.

MEMBERSHIP TERMS & CONDITIONS AGREEMENT

ARTICLE 7: RELOCATION OF FACILITY

- The Center reserves the full and absolute right to relocate, transfer, merge, or reorganize its training facility within the Kingdom of Bahrain due to operational, security, administrative, investment, or organizational reasons.
- Such relocation shall not entitle the Member to terminate the agreement, request a refund, or claim compensation, provided that a reasonable alternative location is made available to continue services.
- Notification through approved communication channels shall be legally sufficient, and continued use of services shall constitute acceptance of relocation.

ARTICLE 8: TEMPORARY OR PERMANENT CLOSURE

- The Center may temporarily suspend operations due to war, security tensions, government directives, pandemics, natural disasters, utility interruptions, maintenance, or any event beyond reasonable control.
- No refunds, extensions, or compensation shall be owed during such temporary suspension.
- In the event of permanent closure for operational, financial, administrative, or force majeure reasons, the Center may terminate memberships without legal obligation to refund unused portions. Any partial settlement shall be at the sole discretion of the Center and shall not constitute a binding obligation.

ARTICLE 9: TERMINATION OF MEMBERSHIP

- The Center reserves the absolute right to cancel or terminate any membership without compensation if the Member or guardian violates any rule, policy, or regulation of the Center.

ARTICLE 10: LIABILITY WAIVER & MEDICAL DECLARATION

- The Member acknowledges the nature of martial arts training and accepts inherent risks associated with physical activity.
- The Member releases and discharges the Center, its management, instructors, and staff from any legal liability for injuries, damages, or losses sustained during training.
- The Member confirms that he/she is medically fit to participate and does not suffer from any condition that prevents safe participation.
- The Member assumes full responsibility for any medical complications arising from failure to disclose medical conditions.

ARTICLE 11: DISCIPLINE & CONDUCT

- Members must maintain respectful behavior at all times.
- The Center reserves the right to take disciplinary action, including immediate termination of membership.

ARTICLE 12: MEDIA & PRIVACY

- The Center reserves the right to photograph and record training sessions and events and to use such media for promotional and marketing purposes without additional consent.
- Security cameras may be used for safety and monitoring in accordance with the laws of the Kingdom of Bahrain.

ARTICLE 13: NOTICES

- All communications sent via SMS, WhatsApp, email, official social media accounts, or displayed on Center notice boards shall constitute valid and legally binding notice.

ARTICLE 14: AMENDMENTS

- The Center reserves the right to amend or update these Terms at any time. Continued use of services after amendments shall constitute full acceptance of such changes.

ARTICLE 15: GOVERNING LAW & JURISDICTION

- This Agreement shall be governed by the laws of the Kingdom of Bahrain.
- Any dispute shall fall under the exclusive jurisdiction of the courts of the Kingdom of Bahrain.
