## Terms and Conditions of ALBANNA Martial Arts Center (AMAC) (Regulatory Policy)

Please read these terms before agreeing to join. Your acceptance of these terms is a requirement for membership.

The terms and conditions of the ALBANNA Martial Arts Center are established to facilitate the smooth operation of training sessions in accordance with the rules. They help create a safe and enjoyable environment for both members and staff.

- **Attire:** All participants are required to wear the official uniform of the available programs or adhere to the dress code established by the AMAC. No player will be allowed to enter or participate in any training unless they follow the dress code.
- **Accessories:** To ensure the safety of both trainers and participants, no accessories are allowed during training sessions.
- **Footwear:** Shoes are not permitted in the training area unless instructed otherwise by the trainer.
- **Bags:** AMAC assumes no responsibility for the safety of your belongings and bags. Students are responsible for safeguarding their property and should never leave items at the center under any circumstances.
- **Personal Belongings:** Players acknowledge their individual responsibility for the security and care of their personal belongings. AMAC is not liable for incidents involving the loss, theft, damage, or misplacement of personal items.
- **Food and Beverages:** No food, cups, cans, or water bottles are allowed in the training area. Only plastic water bottles with secure lids are permitted to prevent liquid spills on the mats.
- **Chewing gum, soft drinks, energy drinks, and any type of meals (including canned foods and snacks)** are prohibited inside AMAC. Only water in secure plastic containers is allowed. In case of violation, the player or their guardian will be responsible for any consequences resulting from the use of such beverages or meals, and may incur a financial penalty.
- **All players must bring mandatory protective gear for all training sessions.** The trainer has the right to deny entry to any player who fails to comply.
- **Club Access:** Members of the AMAC are not allowed to use any other facilities at the Manama Club at any time, except for designated restrooms.
- **Players, guardians, or accompanying individuals are not permitted to access or use any facilities of the Manama Sports Club, except for designated restrooms as indicated by AMAC.**
- **Belt Promotion Tests:** Belt tests are mandatory for continued participation in our program, and test dates are set by the head coach. Testing fees must be paid at least one week prior to the test dates. Failure to pay the testing fees will result in the suspension of the player and their membership until the fees are settled.
- **All belt promotion tests are mandatory to ensure the effectiveness of your membership at the center.** Test dates and player readiness are determined by the head coach, and players must pay the full test fee at least one week before the designated date. Any delays or failures to pay the testing fees on time will result in automatic suspension of the player's membership without prior notice or compensation.
- **Memberships are non-refundable, non-deferrable, non-freezable, and non-transferable to any other player under any circumstances.**
- **Prices are fixed and non-negotiable under all circumstances.**
- **Parental consent is required for those under the age of fifteen wishing to obtain membership at AMAC.**
- **Players must ensure their membership is valid and renewed on time to guarantee attendance in all training sessions.**
- **The child's guardian is fully responsible for the child before and after training, including dropping off and picking up from the center.** Guardians or authorized individuals must be present at the specified end time of sessions.
- **AMAC reserves the right to reschedule training sessions in accordance with management decisions without the obligation to refund any fees.**
- **Official communication from AMAC with players or guardians will be conducted through social media and the center's electronic accounts, as well as via mobile messages to the registered numbers on the registration forms.** The center is not responsible if the registered contact number is changed, and players or guardians must update their contact information to ensure receipt of messages from the center.
- **Official holidays and breaks at the center follow the holiday calendar of the Kingdom of Bahrain (which includes a comprehensive list of national, religious, and public holidays throughout the year).** The center does not follow a policy of rescheduling canceled sessions during this period.
- **AMAC informs players benefiting from promotions that renewal fees will adhere to the center's original pricing policy.**
- **AMAC clarifies that its policies do not allow for double promotions (e.g., combining sibling discounts with promotional offers).**
- **All players at the AMAC are eligible for only one special offer per year.**
- **AMAC requires all new players, including those benefiting from special offers, to pay a one-time registration fee of 10 BHD upon their first enrollment date.**
- **The center has the right to photograph by any means (video/photographic) players or individuals present for any reason at any time and to use these images freely for any promotional or operational purposes without monetary compensation or prior permission (this condition is exempt for the women's team, as player consent will be obtained before publishing any images or videos including them).**
- **AMAC reserves the right to close training programs in the event of precautionary measures due to epidemics, crises, disasters, or any uncontrollable situations without prior notice or compensation.**
- **AMAC may close any training program in cases of precautionary measures, epidemics, infectious disease outbreaks, wars, fires, explosions, power outages, or natural disasters that are extraordinary and uncontrollable, affecting the safety of administrators, trainers, and players without prior notice.** Consequently, players have no right to claim any financial compensation or rescheduling of sessions during this period.
- **Parents, guardians, or companions are not allowed to remain inside the center during training sessions for any reason.**
- **Players or their guardians must inform the trainer of any health issues before participating in training sessions.** In all cases, the participant assumes full responsibility for their personal safety.
- **Players must take adequate care for their safety and the safety of others, following the trainer's instructions during, before, and after exercises.** The center assumes no responsibility for any injuries to players.
- **Entry to the center outside of working hours or during periods without staff is prohibited and considered a violation.**
- **The center reserves the right to add or stop sound effects at any time, and players have no right to object.**
- **To avoid embarrassment, bringing visitors or children to the club is strictly prohibited.**
- **No participant has the right to object to the number of attendees in training sessions.**
- **AMAC reserves the right to conduct media and marketing coverage during training sessions and sporting events.**
- **Personal hygiene is mandatory, and any member causing an offense in this regard will be asked to rectify the issue or leave the center.** Membership may be revoked at the center's discretion.
- **AMAC aims to create a community through its social media platforms, facilitating communication and providing a forum for expressing opinions and suggestions.** Offensive posts, including any content deemed inappropriate at the absolute discretion of our management, may be subject to corrective actions, including removal of offending posts, banning access, or termination of membership due to unacceptable behavior.

The management of AMAC reserves the right to cancel any membership in the following cases:

- If a player behaves improperly, disturbs others, or fails to comply with the laws of the Kingdom of Bahrain or the center's internal regulations.
- Inappropriate comments on any of AMAC social media channels.
- Any verbal or physical abuse directed at any coach, administrator, or members of the center by players, their guardians, or companions.
- Vandalism of the center's property.
- The participant/parent acknowledges that they have read all the terms and conditions contained in this document and agrees to them.
- Participation in the club is considered implicit consent to these terms and conditions, and the participant is required to fully comply.
- This policy is subject to periodic updates based on management directives, and all updates are binding for participants upon announcement.
