Whereas Breeder agrees to sell Purchaser a Jack Russell Terrier for the purchase price of \$ _____

This agreement is subject to the following terms and conditions:

1. The Breeder guarantees, to the best of his ability, that the above mentioned terrier is healthy and free of disease. The Purchaser reserves the right to have the above terrier examined by a veterinarian within 72 hours at the Purchaser's expense. If the above mentioned terrier is found to be unhealthy, the Purchaser will return the terrier to the Breeder immediately, and the Breeder will either (1) replace the terrier; or (2) refund the purchase price; or (3) return it in good health within thirty (30) days. In such an unlikely case, the adverse health report must be in writing and signed by a licensed veterinarian.
2. Terrier is guaranteed until two years of age against genetic/congenital defects that would prohibit the terrier from leading a quality life. In such an unlikely case, a written report must be submitted signed by a licensed veterinarian. The puppy will be replaced or the purchase price will be refunded at the Breeder's sole discretion.
3. The Breeder guarantees that said terrier will qualify for registration with the Jack Russell Terrier Club of America, Inc. (JRTCA) at one year of age. If said terrier does not qualify for registration at one year of age, Breeder agrees to replace said terrier or refund the purchase price at the Breeder's sole discretion. The Purchaser must notify the Breeder in writing of the unregistrable condition, and include a JRTCA veterinarian certificate dated and signed by a licensed veterinarian, within thirty (30) days after said terrier turns one year of age. If the Breeder does not receive notification within 60 days after said terrier turns one year of age, this guarantee becomes null and void.
4. Purchaser shall use the kennel name prefix _____ when exhibiting and/or registering said terrier.
5. Purchaser agrees that said terrier will be registered with the JRTCA upon reaching one year of age. The Purchaser further agrees to have no association with any conflicting JRT organization or kennel club (relating to Jack Russell Terriers).
6. The above mentioned terrier may not be sold or given away, in whole or in part, by Purchaser without the prior consent of the Breeder, who shall have a first right of refusal. In this event the Purchaser agrees to offer said terrier to Breeder for no more than the above purchase price. **Under no circumstance will the above terrier be relinquished to any Shelter, Animal Control Agency, Rescue Organization** or any other organization or individual.
7. The Purchaser further agrees that they will never place this terrier, or any of its offspring, should it be used for breeding, in any pet store or other public-sales situation.
8. This agreement represents the entire agreement between the Breeder and Purchaser. No other agreements or promises, verbal or implied, are included unless specifically stated in this written agreement.
9. If the Purchaser fails to adhere to this contract in part or in whole, the Purchaser agrees to pay any and all fees, including but not limited to legal fees, court costs, depositions, telephone, veterinary examinations, etc. incurred by the Breeder and its agents to enforce this contract. The Purchaser agrees that any court papers shall be filed in the Breeder's city of residence.
