

# **Dewbury Dream Goldens Stud Contract**

## **Requirements:**

1. Bitch must be at least 2 years of age
2. Bitch must have all her OFA final clearances, Hip, Elbow, Heart, & Eyes
3. Bitch must be AKC registered and a full-blooded Golden Retriever
4. Bitch must have "Good" or 50% pennHips, or better.
5. Dewbury will be sent pictures of all the puppies, and included in any puppy Facebook or Instagram page.

Offspring of this litter must be sold as LIMITED REGISTRATION ONLY, except for one Male OR Female of dam owner's choice. This puppy will be FULL REGISTRATION for the dam owner's own program only. It must have all its OFA health clearances done before breeding it, and it may under no circumstances be bred with any other breed than a Golden Retriever. Failure to comply with the above-mentioned limitations will result in a minimum of \$ 20,000 to be paid to Dewbury Dream Goldens.

## **Dewbury Dream Golden Guarantee:**

1. The Stud will not be collected 2 days prior to the collection of the above-mentioned bitch, as to not exhaust his sperm count.
2. The owner of the stud will only charge the full stud fee upon the birth of at least 3 puppies.  
In case of only 2 puppies being born, the stud fee will be cut I half. (\$ 1,000) \*Veterinarian's note required.  
If there is only 1 puppy born, the fee will be ¼ of the stud fee. (\$ 500) \*Veterinarian's notes required.
3. If the breeding does not take, Dewbury Dream Goldens will refund \$ 2,000 of the stud fee, except \$500 for traveling and the time spent on facilitating the mating.

**Stud fee: \$ 2500      Cash, Venmo, or PayPal ONLY**

**All vet & shipping expenses are to be paid by the dam owner prior to semen being shipped out...That expense is not considered a part of the stud fee.**

The full payment is expected **before** any semen is collected and sent out. It will be deposited into a separate bank account, where it will stay until the pregnancy is confirmed. \$ 500 of this fee is non-refundable, which will cover the traveling fee or/and the time spent on facilitating the mating.

If using frozen semen, the stud fee is a flat \$ 1500, and the \$ 500 non-refundable fee still applies, as the stud owner had to travel to get the stud collected for this.

If Dewbury does not hear from you after 30 days of insemination or mating, we will assume that the impregnation/mating was successful, and the money will be rightfully Dewbury Dream Goldens'. The responsibility of communication of the confirmation of pregnancy falls sole on the bitch owner.

The owner of the above-mentioned bitch agrees on this date \_\_\_\_\_ (Initials) \_\_\_\_\_ that the stud fee must be paid in full to the sire owner before the AKC litter application will be signed.

*Note: The American Kennel Club takes position that the owner of the sire is required to sign an application to register a litter, certifying only to the fact that a particular dam was bred to the sire identified on the Litter Registration Application Form on a specified date of mating, unless there is an agreement signed by all parties concerned in which it is specifically set for that the owner of the sire is not obligated to sign an American Kennel Club Litter Registration Application for until such time as the stud fee has been paid in full.*

This contract is null & void if dam owner does not provide the AKC required certificates and the SIGNED contract to the stud owner BEFORE the breeding.

If the weather makes it impossible for Britta Nielson to travel to the repro vet to get the Stud collected, dam owner understands that she might use their back-up stud, (Which is always considered good practice to have in place no matter what) If the weather inhibits Britta Nielson to travel to Repro vet, the full stud fee will be returned to the bitch owner.

Dam owners will not use any of the semen, or the Stud's offspring for cross-breeding. If doing so, the dam owner will be in breach of contract, and there will be a minimum penalty of \$ 30,000 to be paid out to Dewbury Dream Goldens.

In the event of any court or litigation proceedings in connection with this contract, the Dam Owner will pay the Stud Owner's attorney fees. The venue and jurisdiction for litigation arising out of or related to this agreement shall lie solely in Washington County, Utah.
