ADVERTISEMENT FOR BIDS

**Village of Sheridan
Water System Improvements - Contract 1A**

The **Village of Sheridan** is requesting Bids for the construction of ***Village of Sheridan Water System Improvements – Contract 1A***. Bids for the construction of the Project will be received at the Village Hall located at 115 E Evergreen St, PO Box 179 Sheridan, MI 48884 until **3:00 PM** local time **Thursday, June 12, 2025**. At that time the Bids received will be publicly opened and read.

The project includes the construction of approximately 10,800 feet of 8-inch water main, including directional drilled HDPE, open-cut PVC, and Ductile Iron, and 220 feet of 6-inch water main, along with approximately 3,400 LF of associated copper water service pipe and 75 meter pits, throughout the Village of Sheridan. Road reconstruction includes improvements associated with water main improvements, including approximately 2,000 tons of HMA, ADA ramp replacement, pavement markings, traffic control, and all related work.

Prospective Bidders may request the Bidding Documents from the Issuing Office. Bidding Documents will be emailed in portable document format (PDF) at no charge; hard copy documents are not available. In addition to the Issuing Office's Bid Room, Advertisement for Bids will also be distributed to the Michigan Infrastructure and Transportation Association (MITA), McGraw-Hill Dodge, Construction Association of Michigan, and the Lansing/Grand Rapids Builder's Exchange. Builder's Exchanges are authorized to share the contract documents with other exchanges.

The date the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents.

A pre-bid conference for the Project will be held on Wednesday, May 28, 2025 at 10:00 AM Village Hall located at 115 E Evergreen St, PO Box 179 Sheridan, MI 48884. Attendance at the pre-bid conference is encouraged but not required.
