WAVE DANCER will provide: Kitten/cat in good health

- Sterilized
- De-wormed,
- Vaccinated,
- Micro chipped and registered in the new owner's name
- Registration in the new owner's name with CCA and/or CFA
- Pedigree showing the ancestors of the kitten
- Health certificate signed by a licensed veterinarian.

A deposit of \$500.00 is required to reserve a kitten. Deposits are accepted by cash, PayPal or electronic funds transfer using the following e-mail: wave.dancer@hotmail.com A receipt will be issued for the deposit. Deposits are non refundable after the kitten/cat has been sterilized. The balance due for a Devon Rex kitten is due prior to reception or the shipping date or upon delivery of the kitten. All fees for any necessary airfare and transporter must be paid in advance, airfare receipts will be sent with the kitten. All fees for other transportation are due upon delivery.

The kittens will be de-wormed and vaccinated with the first, second vaccinations. Vaccinating against FeLV (Feline Leukemia) and FIP (Infectious Peritonitis) and/or Chlamydia, or vaccinating with live vaccines is not recommended. If the Buyer and their Veterinarian decide to give either of these vaccines, WAVE DANCER shall not be held responsible in any way. No refund or replacement will be given. **IMPORTANT:** Use only food from Purina, Royal Canin, Hills Science Diet, Oven Baked Traditional, Nutrience or Farmina. Avoid other brands because they give our cats diarrhea and can be harmful. Our vets tell us that <Boutique< food brands are **seriously** to be avoided. So please, do not feed other than the recommended foods because our health guarantee is void with those foods. In addition to dry food, you can add a tablespoon of canned food if you want, (Friskies paté) or raw meat because our cats love it.

The Buyer agrees to give the cat/kitten the best possible care. The Buyer will at no time allow the cat/kitten outside unattended. The Buyer agrees not to declaw the cat/kitten.

WAVE DANCER makes no representations or guarantees whatsoever as to the physical features, attributes, personality or temperament of said cat. Within 72 hours of receipt of the cat, the Buyer may, at his option, have the cat examined by a licensed veterinarian. If such veterinarian certifies to WAVE DANCER within one week of such examination and/or any blood test, that the cat has a serious illness, WAVE DANCER must be notified immediately, and the cat must be returned with a copy of the veterinarian report. In such case, upon receipt of the cat and veterinary report of illness WAVE DANCER will refund all moneys paid to WAVE DANCER. Upon no condition shall WAVE DANCER be responsible for payment of any medical treatment provided to the cat by the Buyer during the time in which the cat is in the Buyer's possession, nor shall WAVE DANCER be responsible for any other miscellaneous expenses, i.e.; transportation, shipping etc. The cat is not guaranteed against Feline Infectious Peritonitis. In the event of the death of the cat, Buyer must provide a copy of complete necropsy report. All guaranties are null and void if the cat is fed with any commercial kibble food other than Hill's Science Diet, Royal Canin, Purina, Farmina or Oven Baked Tradition.

WAVE DANCER agrees to replace the cat/kitten with respect to the following: WAVE DANCER agrees to replace the cat/kitten in the event the cat/kitten dies of any other congenital defect within the first year of its life. A veterinary autopsy/necropsy must be provided at the purchaser's expense to verify cause of death. WAVE DANCER will replace the cat/kitten with another cat/kitten of similar quality when available. If Buyer does not want a replacement cat/kitten, WAVE DANCER will have no further obligation towards Buyer

The Buyer will not give, lease, loan or sell the cat/kitten to another person, institution, animal shelter, cattery or any similar entity without WAVE DANCER'S written approval. If the kitten is transferred to another person, the new owner(s) must agree to abide by these terms. Note that if this kitten is being purchased as a gift for a family member this is not considered a transfer to a new owner, the family member is considered as the first owner.

The Buyer will not voluntarily cause or ask an agent to cause the untimely demise of the cat/kitten without a veterinarian's certification that such is necessary for veterinary or humane reasons.

Please note that during times of stress, such as going to a new home, cat/kittens can exhibit temporary signs which may include: sneezing, runny nose, watery eyes, diarrhea and/or constipation. To help reduce the signs of stress feed the cat the identical food that the breeder was feeding, and offer bottled water, as well as taking reasonable measures to reduce stress. You can do this by slowly introducing them to the house and the members of the household, as well as limiting the time they are with strangers, toddlers and other animals. We take the time to socialize our kittens to help shorten the period of adaptation, so please take note of your kittens stress level and help them to adapt.

Devon Rex are very sociable animals which enjoy being with humans and will suffer from lack of attention. Please take the time to play, talk and love your Rex. The more love and attention you give them, the more you will get in return.

Note: The balance due of _____ is payable on delivery in cash or electronic transfer only. A receipt will be provided for all. A discount of \$100 will be given for other kittens that are purchased by the same buyer.

CONGRATULATIONS ON YOUR NEW KITTEN!

Here is the information you need.

Litter:

This is a personal choice, but we use regular litter (Special Kitty available at Wal-Mart or Selection from Metro) or silica litter-small grains also Tofu or Pea Husk litter for our kittens..

Food :

Now the cats are eating Royal Canin Kitten with Pro Plan Kitten (available at JE Mondou). For the adults we recommend Royal Canin Indoor Cat or Purina Pro Plan Adult
IMPORTANT: Use only food from Purina, Royal Canin, Hills Science Diet, Oven Baked Traditional, Nutrience or Farmina. Avoid other brands because they give our cats diarrhea and can be harmful. Our vets tell us that <Boutique> food brands are seriously to be avoided. So please, do not feed “boutique” foods because our health guarantee is void with those foods.

In addition to dry food, you can add a tablespoon of canned food if you want, (Friskies paté) or raw meat because our cats love it.

Grooming :

We will show you how to cut the claws and clean the ears if we meet you for the kitten/cat delivery.

You will need a claw cutter made for cats.

Make up remover pads (tampons) and Special Ear Cleaner liquid to clean the ears, the liquid is available from veterinarians. IMPORTANT Never pour the liquid into the ears and massage the ear as this can damage the ear.

It is recommended to cut the claws and clean ears every two weeks.

Vaccinations :

The next vaccination is due according to the date on the latest vaccination certificate that comes with your kitten.
