AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF GRAND RIVIERA RV RESORT SUBDIVISION

WHEREAS, Grand Riviera RV Resort Subdivision Owners' Association, Inc., does wish to amend and revise the Declaration of Covenants, Conditions of Grand Riviera RV Resort Subdivision, dated and filed in the Office of the Judge of Probate of Baldwin County, Alabama, on May 24, 2023 as Instrument Number 2065920; and,

WHEREAS, said proposed revision was approved by its Board of Directors while under Developer Control pursuant to Article XI of said Declaration.

THEREFORE, the Declaration of Covenants, Conditions and Restrictions of Grand Riviera RV Resort Subdivision, is hereby amended as follows:

Article V, Subparagraph 5.04 is hereby amended to read as follows:

5.04 <u>Rental of Lots</u>. Any Lot Owner shall be allowed to operate as his own rental agent, renting only his own property. However, that Owner shall not be allowed to "manage" other rentals for other Owners. Only the rental management company designated by the Association shall be allowed to represent and manage rentals otherwise. The provisions of this Subparagraph 5.04 may not be amended without Declarant's prior written consent or after the Declarant has turned over the Association by the affirmative vote or agreement of the Lot Owners of at least eighty percent (80%) of the Lots.
