LOL District Board Review Committee Proposal Submitted by Larry Lewis

It was recommended at the 2018 Fall District Convention that a committee be appointed by the President to review the responsibilities of the District Board and all committees to determine an optimum structure and committee member composition. The committee was asked to share these findings with the Board and make a recommendation for any changes at the 2019 Spring District Convention.

The members appointed to this review committee: Larry Lewis (Chairman), Dan True, Gordon Billows, Steve Zorn and Arv Zenk. The review committee met at 8:00 a.m. on January 12, 2019 at the Leadership Training Academy – Steve Zorn was unable to attend. The following are the findings of this committee and it is recommended that the Board adopt these changes.

The LOL Board needs to be restructured and some responsibilities need to be realigned to working committees which will more effectively support our chapters and the District. It is recommended that the Board membership be reduced from 14 positions to 8 with the following structure:

President

Executive Vice President Immediate Past President

Secretary

Treasurer

Vice President West Division (Currently Northern Plains – 8 chapters)

Vice President Central Division (Southwest and 10,000 Lakes – 19 chapters)

 $\label{eq:continuous} \mbox{Vice President East Division (Packerland and Division One-19 chapters)}$

This Board structure would change the Divisions as we know them eliminating 2 division vice president positions, but the committee felt that 3 vice presidents could manage the chapter advocates for the 46 chapters more effectively. Division contests for these areas have been combined for a number of years and the committee felt that this structure would streamline management and actually improve communications.

This Board structure eliminates the following Board positions with the responsibilities shifting to committees:

Vice President District Events

Vice President Contest and Judging

Vice President Education and Leadership Development Vice President Chapter Support and Development

The activities and all of the responsibilities for District Events and Contest and Judging have been very effectively handled by the committees associated with these functions. In the future, the chairman of each of these committees will report directly to the District President to coordinate all events and contests. The review committee does not feel that this is a significant change or will detract from overall operation.

The review committee recommends combining the current responsibilities and functions of the Education and Leadership Development and Chapter Support and Development areas into a single committee. This would be a new committee responsible for all of the functions outlined in the current job descriptions for the eliminated vice president roles. The review committee suggested that the title for this committee might be "Chapter Engagement and Support" and



LO'L Youth in Harmony Update!

Looking back, it's clear the LO'L District has much to be proud of in our Youth in Harmony efforts thus far in 2019!

The \$10,000 we sent to the Harmony Foundation lent support to some of the more than 800 students who participated in the Midwinter Convention in Nashville! Not only that, but Vintage Mix (a mixed quartet from Waukesha, WI) finished 1 point behind the winner and tied for 2nd in the Junior Quartet Contest, while **Best Sellers** (a treble guartet from Onalaska, WI) finished 5th. The **Here Comes Treble** (a treble chorus from Burlington. WI) and **Prairie Chords** (a mixed chorus from Saskatoon) participated in the Next Generation Chorus Invitational receiving an Outstanding and Good rating, respectively!

There were five successful Youth in Harmony Festivals that took place in January and early February in Oshkosh, Windom, Fargo, Stevens Point and Willmar. The one scheduled in West Allis was postponed to March 30th due to a snowstorm. (Imagine that!)

Looking ahead, there are even more encouraging things brewing! The 5th Annual Wisconsin Youth Harmony Festival (WYHF) will be held on Saturday, May 18th in Stevens Point. That will again bring quartets from across the state to learn more about barbershop harmony and crown the best barbershop and treble quartets in Wisconsin.

Vocality is going "Digital"! Submitted by Jay Althof

Many of us are old enough to have experienced the changes in how music is distributed from LP Records, to 8 track and cassette tapes and for many years, CDs. But now, many newer cars don't even have CD players and finding computers and sound systems with CD players is challenging as well. Music is being distributed from digital platforms on streaming services like iTunes and Spotify. But many people in our audiences still enjoy the opportunity to purchase a whole album, not just try to find one song at a time. What to do?

We worked with the firm that produced our four albums to find a solution. And that solution is that each of our albums are now available to download from a company called SoundTrax. When someone purchases our album, they get a unique code, then just go to the SoundTrax website, enter the code and download all the songs from that album to their computer or phone or other digital music device.

Of course, for those that would still like the physical CD, we have those, but now we have another option as well. If you'd like to learn more about how this process works for your quartet or chorus, feel free to reach out to us, and we'll share our experience.

We have several shows lined up for this year and are excited to be part of those chapter shows. And we still have a few open weekends that are available in 2019 for us to perform for your audiences. We continue to add new songs to our show packages and

would love to share them with you! Connect soon so we can get your show on our schedule.

The review committee recommends that these changes be adopted at the 2019 Spring District Convention and that implementation of this restructuring be completed before the nomination and election of Board officers for 2020.

Manitowoc's Clipper City Chordsmen Receive Prestigious Community Service Award

The Clipper City Chordsmen were honored as recipients of the 2019 Wesley Teply Community Service Award In the Arts. This award was established in 1999 by the Lakeshore Wind Ensemble Association to recognize individuals or groups who have substantially contributed to the arts in the greater Manitowoc area.

The 2019 Award was presented to the Clipper City Chordsmen during the Lakeshore Wind Ensemble's "Winds of March" concert on Saturday, March 2nd at the Capitol Civic Centre in Manitowoc. Representatives of the chorus were present to accept the award and to perform as part of the concert program. The chorus was presented with a plaque commemorating the award in addition to having their name permanently displayed on a plaque in the Music Department on the campus of the University of Wisconsin - Manitowoc

David Bourgeois, a 20 year member of the Lakeshore Wind Ensemble presented the award to the Chordsmen. He stated "The Clipper City Chordsmen donate both time and money to serving organizations and charities, provide support to local music education using grants to area schools, and strive to improve the quality of life for their members and the community."

Bourgeois went on to say "On a personal note, my life and musical career was jump started by this outstanding organization in 1981. As a sophomore at Michicot High School, I was presented with a \$200 scholarship from the Clipper City Chordsmen to attend a summer music camp. I still remember going to one of their rehearsals to thank them and to listen to them practice. This is just an example of the thousands of lives this organization's music and generosity has touched.

The Clipper City Chordsmen was founded in 1945 by O. H. "King" Cole under the direction of Milt Detjen. They currently have forty members representing all ages and walks of life. The Clipper City Chordsmen perform locally including annual Spring, Summer and Christmas Shows as well as Singing Valentines in February and visitations to area assisted living/nursing homes and hospitals. They also perform with other choruses and for special events throughout the year.

Their mission states, "The Clipper City Chordsmen Chorus is an ever-growing, well-respected brotherhood of men who love to perform a cappella music in the barbershop style, preserving the heritage of the barbershop quartet. The Chordsmen strive to improve the quality of life for our members and our community through music education programs and family-friendly musical entertainment."

2019 Youth In Harmony

The Windom **Chordhustler** Chorus held our 15th annual Youth In Harmony Festival on January 19, 2019 at the BARC Center in Windom Minnesota. We had 46 enthusiastic students (26 girls and 20 boys) from 5 area schools (Windom, Red Rock Central, Westbrook Walnut Grove, Butterfield-Odin, Martin County West and 2 home school students.) attend this year. The students worked on music throughout the day with two excellent quartets, "**Fourte**", a Sweet Adeline's quartet from the Moorhead Minnesota area, and "**Vocality**" a men's barbershop quartet, (their 8th time helping us with this event.) from the Twin Cities. The day started at 9 AM with warmups. After warm ups we gathered on stage to practice the 8 part songs as a mass choir. Students then split up to work on their 4-part music with the clinicians until the noon break. After a noon lunch of pizza the

students returned to their practice rooms to continue working on music. After the afternoon break all groups joined on stage to practice the 8 part songs for the 4 PM concert.

The afternoon concert was at 4 PM with all groups performing. The **Chordhustlers** started the concert, with **Fourte** singing next followed by **Vocality**. The **Young Men in Harmony** then presented "Come Fly With Me" and "Can You Feel The Love Tonight". Then the **Young Women in Harmony** sang "One Fine Day" and "The 59th Street Bridge Song" (Feelin' Groovy). The finale of the day was all groups coming together on stage to present two 8 part songs "If There's Anybody Here From Out Of Town" and "Harmony". It is always a very rewarding feeling to offer this event to students and see them become excited about singing barbershop style music. We would like to thank the Robert and Helen Remick Charitable Foundation Trust for helping to sponsor this event.





At the January 2019 LTA Board meeting your LO'L Board voted to restructure the current LO'L Contest system. Currently both Quartets and Choruses are required to qualify for the Fall District Contests at a Spring Division Contest. SCJC requires that Contests be scored on site by Society Certified Judges and with increasing traveling costs, along with declining membership and participation, this has become very expensive, especially with the size of the LO'L District requiring the need to hold Division Contests in three locations.

So what is the proposal to restructure the current contest system? Eliminate Current Division Contests qualification requirements. Replace with: all quartets and choruses singing 65.0 or better at the previous fall contest will be qualified to enter the next fall's District contests.

We sang 64.5 so how do we qualify for the fall contest? With the elimination of the Spring Division Contests, all other Land O'Lakes Men's Choruses and Men's Quartets (including Seniors and Novice) wishing to enter the Fall Land O'Lakes District Contests, will need to attend and be videoed, at an LO'L Regional School/Festival held the Spring prior to the Fall District Contests. These videos will be uploaded by Saturday night into a (Drop box/You Tube) to be scored by Certified Judges, with the scores returned to the District C&J within the week. All scores of 65.0 or better from the previous fall contest and the Spring Schools/Festivals video scores shall be combined and from this combined list the Men's Choruses and Men's Quartet will be invited to the Fall District Contest.

The plan is for the District to hold three (3) regional schools/festivals for Quartets and three (3) for Choruses.

The quartet school/festival will replace the quartet schools that are currently held and the chorus school/festival will replace the

current division contest. The schedule has not yet been finalized.

What about Mixed Choruses and Mixed Quartets? Currently LO'L is offering Mixed Quartet competition at the Spring Convention/Contest, but, has not addressed Mixed Choruses or the qualifications of Mixed Units for competition. This will be addressed as we gather information as to interest in this competition.

Will Schools/Festival reduce costs over the current Division Contests?

They may not, However, the main thrust of these Schools/Festivals will be Coaching with each unit attending receiving a couple of hours of coaching which will replace the 10 to 15 minute Judges evaluation received at contests,. We have many qualified coaches within the District, and will be able secure a number of coaches for each school/festival for the cost of one airfare for a Certified Judge.

The exciting part at this time is there is no string attached to attend. Your unit has the option to enter for District Qualification/Coaching or attend just for the Coaching. The hope is that your unit will take advantage of both qualifying and coaching, however it remains your option, and regardless of the level you are singing, this is a great opportunity to receive Coaching, as there is an old saying "Better singing attracts better singers."

Will there be a cost to attend the Regional/School/Festival? Yes, the amount has yet to be determined. Anticipate it to be similar to the current Division Contest cost.

Will the Division Championship Awards be eliminated? This is under discussion, however, they should be able to award the division chorus and quartet championship at the fall district contests using those scores.

Will there be awards at the schools/festivals? None are in the plan at this time as the scores will not be known until the following week.

NOTE: The video qualification system is not completely new, as it is currently used

by International for qualification for the "Mid-Winter Junior Quartet Contest". LO'L, in agreement with the SCJC, will be using the video qualification at the Northern Plains Division Contest in May 2019.



The All Chapter Chorus is Back! LO'L District Convention -October 25-26, 2019 Submitted by Steve Zorn

The Northern Pines Harmony Brigade (NPHB) is ready to anchor the All Chapter Chorus. Over thirty Brigade members have committed to sing in the chorus.
