Crossroads Housing Development Corporation (CHDC) is a non-profit community organization aimed at helping to identify low-income homeowners with a need for major repairs or roof replacement through the CHDC Raise the Roof Program on their homes that will keep their families healthy, safe and secure.

In order to be eligible for any CHDC Programs, the households must meet the following criteria:

- 1. Your property is on a permanent foundation, either concrete or pier & beam.
- 2. Your property is a single-family residence.
- 3. Your property is within CHDC's service delivery area\*\*.
- 4. You own your property, and it is designated as your homestead.
- 5. The property in need of repair is your primary residence.
- 6. You are currently paid-up in full on your property taxes.
- 7. Your income is 80% or less of the Area Median Income (AMI).
- 8. You must have two (2) forms of identification with at least one (1) being a valid state issued photo ID for the state in which you reside.

CHDC will perform a site visit to confirm items 1, 2 & 3. For items 4, 5, CHDC will verify through the public records of the county that you reside in. For item 7, CHDC will verify with a copy that you provide to us confirming your last 2 years income tax returns or Social Security benefits meet the HUD standards for low-income households. CHDC must keep a copy of your two forms of ID with your program file.

PLEASE NOTE that CHDC programs are on a first come first serve basis. Further, even though you may qualify for our programs and your application is received, there is no guarantee that CHDC will perform any repairs. It is possible that not every applicant that qualifies for services under our programs will receive assistance. CHDC has limited funds for their programs and strict guidelines on how to utilize those funds in assisting those that need it most. CHDC may place you on a waitlist or ask you to re-apply the following year. CHDC has full discretion as to what extent our funds will be used for repairs, the Scope of Work and Materials To Be Used.

Low-Income and 80% of AMI are determined by the U.S. Department of HUD. Scope of Work and Materials To Be Used are non-negotiable, but rather approved or not approved by the homeowner. Any warranty issues related to the materials used must be directed to the manufacturer of said materials.

Crossroads Housing Development Corporation (CHDC) will supply the contractor to perform needed repairs. It is our intent to restore any damages back to their original condition or as close to the original condition as possible.

Scope of Work and Materials To Be Used are non-negotiable. CHDC will try to find materials that closely resemble what is being replaced. If for some reason, you, the homeowner, does not approve of the Scope of Work or the Materials To Be Used to repair the damages, then you must notify the contractor BEFORE they begin work. Once the homeowner has acknowledged the Scope of Work and the Materials To Be Used and work has begun, any stoppage of work or repairs by the homeowner may result in unfinished repairs.





CHDC will provide a six (6) month warranty for the workmanship only from the date of completion. Any project related warranty issues must be delivered in writing to brianswisher@chdctx.org or mailed to Crossroads Housing, P.O. Box 1042, Big Spring, TX 79721 on or before the last day of the stated six (6) month warranty period. Any and all other warranty issues involving material(s) used on the project need to be directed to the company, manufacturer or store that provided the material(s). This means that CHDC will provide a warranty for workmanship only. The homeowner will be responsible to report any material(s) warranty issues and resolve those matters on their own accord.

Program funds are limited and thus service is limited by those funds as to which households we can help. Approval is at the discretion of CHDC and if not approved the applicant may re-apply for inclusion in the next year's program, if still available. We are not required to give the applicant an explanation for not approving an application. Low-Income and 80% of Area Median Income are determined by the U.S. Department of HUD.
