announcements/emails.



Grades are made up of four things: journaling, Packback, three "extended" assignments, and exams.

- You will be asked to read a few chapters each week, will ask a question on Packback with those topics from our chapters in mind and respond to two other questions (this is our "discussion" board), and you will write one journal entry per chapter in your discord journal channel.
- Extended assignments will be assigned three times this semester and will include a graphing worksheet, a summary of a scholarly paper, and one last assignment which is to be determined.
- There will be three exams plus an optional final exam.

# **Course Learning Outcomes**

- 1. Apply graphs of economic variables to produce economic analysis.
- 2. Identify the basic demand and supply theories in the presence of limited resources.
- 3. Relate the equilibrium prices and quantities, and identify the role of prices in organizing economic activity based on the theories in (1).
- 4. Indicate and predict the possible consequences of changes in real world economic conditions and policies, based on the theories in (2).
- 5. Identify different types of market competition; and apply the theory of the firm to locate its effect on prices and production under different types of market competition.
- 6. Recall the definition of externalities and indicate the possible roles played by the government.
- 7. Identify how to measure GDP, the unemployment rate, interest rates, and economic growth, relate their importance and distinguish real and nominal variables.
- 8. Recall the measurement and different types of inflation, and relate the consequences of high inflation.
- 9. Recognize the roles of money, banking, and the Federal Reserve System in the economy.
- 10. Identify and recognize the determinants of short-run changes of economic variables over the business cycle, and that of economic growth over time.
- 11. Identify the factors influencing aggregate demand (AD) and aggregate supply (AS), and recognize macroeconomic conditions using the AD–AS model.
- 12. Identify the tools and relate the goals of monetary and fiscal policy.

Calling on 1 - 12 above, be prepared to relate economic issues and identify the related economic policies.

# **Course Description**

Ethics, Economy, and Entrepreneurship studies commercial society from the perspectives of philosophy, economics, political science, and business. Central questions include:

- Why do some societies grow rich while others remain poor?
- What constitutes a good life and how can one achieve it?
- What role do entrepreneurs play in a commercial society?

Consistent with the interdisciplinary approach, the topics range from abstract philosophical principles to practical tools for daily life. The course comprises six broad units:

- Conceptual Framework
- Social Progress
- Cooperation and Trade
- Commercial Institutions
- Social Challenges
- Entrepreneurship

This course will help you to understand, critique, and thrive in a commercial society. During the course you will:

- Describe the history, causes, and consequences of economic and social progress.
- Evaluate commercial institutions including markets, property, and law.
- Apply common economic theories, models of entrepreneurship, and financial tools.

Mastery of the material prepares you for coursework in business and economics. More importantly, it provides tools to live well in a modern commercial society.

The course also develops general literacies. Specifically, during the course you will:

- Synthesize ideas gathered from multiple sources.
- Draw conclusions based on analysis of empirical evidence and logical arguments.
- Communicate and respond to ideas in writing.

#### Method of Instruction

Asynchronous learning with no required meetings. Short lecture and intro videos on the topics will be provided, and journaling and Packback will be our method of discussion for the course content. You will be provided the opportunity to practice the materials/content as you work through the modules at your own pace.



If you are happy after your first 3 exams, you may choose to not take the final exam and each of the three exams will be worth 10%. If in the case you do choose to take the final, **this cannot hurt you in any way**. If the final exam is better than one of your first 3 exams, it will replace that exam grade. IF you perform worse on the final exam, the grade will be scrapped.

The 4<sup>th</sup> exam, our final exam, will be optional and may be used to replace one exam grade from the first three exams, or if in the case of a missed exam. #### Exam Make-up Policy

No retake exams are offered. If in the case of a missed exam, you may take the final exam in place of this grade. You may make up an exam without notifying the instructor only in exceptional circumstances and with documentation provided. I cannot ask for hospital or medical notes because of HIPAA policies. This means, medical excuses will generally not be accepted. If you miss an exam and have a valid excuse, I will re-weight the relevance of each of the other exams.

#### **Packback Questions**

Participation is a requirement for this course, and the Packback Questions platform will be used for online discussion about class topics. Packback Questions is an online community where you can be fearlessly curious and ask open-ended questions to build on top of what we are covering in class and relate topics to real-world applications.

#### Packback Requirements:

Your participation on Packback will count toward 25% of your overall course grade.

There will be a Weekly Friday at 11:59PM EST deadline for submissions. In order to receive full credit, you should submit the following per each deadline period:

- 1 open-ended Question every week with a minimum Curiosity Score of 60, worth 33.33% of each assignment grade
- 2 Responses every week with a minimum Curiosity Score of 60, worth 66.67% of each assignment grade
