

2020-21 DIRECTORS' EXPENSES

According to RI Bylaws section 18.080, Rotary International is required to report all expenses reimbursed to, and all payments made on behalf of, each of the directors.

The principal expense of the directors is mandatory travel related to attendance at Board meetings (four meetings annually) and other expenses such as attendance at the Rotary International Convention, and the International Assembly.

The board meetings are held in Evanston, Illinois, USA or in other locations that coincide with the International Assembly or Convention. Directors are also reimbursed for expenses associated with their duties as director, including visits to clubs and other travel, attendance at meetings convened by the president, attendance and planning expenses for the Rotary institute(s) he or she is responsible for convening, attendance at no more than one other institute, and miscellaneous expenses.

See RI Code of Policies section 69.040. for additional information about officers' expenses.

Rotary International's financial statements for 2020-21 include total expenses of \$29,558 for the directors. As a result of the COVID-19 pandemic, the Board meetings and Taipei Convention (and associated meetings) were held virtually and as such no related travel expenses were incurred for these meetings.
