- Resource Conservation District C-20 Greenbelt update If weather holds, the contractor may start at Park Creek Road but more than likely they will not reach C-20 (East of Pearl and Garnett) until Spring.
- USDA Grant Update We have requested to renew our application with changes in 2021. With the Good Neighbor Policy project moving forward we could reduce the amount of acreage approx. 50 acres thereby reduce funding requested, which could help for a more positive result...AWARD.
- Stephens Grant update Grizzle Flat and Sierra Springs were placed on the application instead of Gold Ridge Forest.
- NO CalFire Grants to apply for in 2020.
- Additional grants "Education" "Roadside clearing" are coming up and we will move on those as so as we hear more. Recommended that we get together to decide what additional work we would like to do beyond the greenbelts.
- Meeting recordings and/or live feed Not on EDC FSC agenda but hopefully it will be in January.
- GMRS communications Coming in 2021 prior to fire season. The EDC Amateur Radio Club now plans to expand this to Pollock Pines, Sierra Springs and Sly Park Hills.
 Extensive training will be needed prior to start up.
- GRF Community Event Sept. 13th Over 100 residents attended, and many made new friends. Great presentations on GMRS communications and Home Hardening. Raffle went better than expected.
- CEDAPP's National Night Out Oct 6th Sherry Hawk attended and had a table with special fire safety booklets for kids and the fire simulation video for our area. Lots of agencies attended and had a great raffle and great activities for kids. We honored our first responders!!

PGE - I do have a PGE a rep we can reach out to if you have any questions. CODE RED - Only notifies you when you need to evacuate. Fire near Volcanoville had a failure of CODE RED. Majority of the problem is that people have not set up the application.

- EDC Vegetation Management Sherry man supplied feedback from the residences to the ordinance division and they will be meeting with her next week. Responses will be sent via email to the community and addressed at the next meeting.
- Rich Wade brought up that the area that is 0-5 feet from the home will now need to be cleared of any combustible items as of 2021. This includes flammable plants such as junipers and rosemary, wood piles, scrap wood and more. It is also understood that some home hardening items will be mandatory if you are selling the home. More information to come as it becomes available.
- **7. CWPP (Community Wildfire Protection Plan):** Rich Wade and Sherry Hawk Rich submitted work that has already been completed east of Sly Park including Fire Adaptive 50, for the contractor to add to their maps. They were not aware so it will make a difference and refine the plan for our community.
