

## **June 25, 2025 GRF Board Meeting Minutes**

### **Previous Meeting Minutes Approval**

### **Greenbelt Update**

Jack Mermod-Cornerstone will be taking down 6 hazardous trees in the greenbelt next week.

### **Finance**

Mark Weiner-See reports, Note, the total balance with reserve and operating accounts are \$571,000 roughly in 2025, last year 2024 total was \$495,000.

The board has reviewed the reports, Mark Weiner-motion to report they have been reviewed, second, Jack Mermod, all in favor.

### **Recreation**

Jack Mermod-the pool season is under way with no major issues. We have discovered a hole in the asphalt in the basketball court; I will request our paving company to fill it when they are here working.

We have had requests from members to fill cracks in the tennis courts; we will research contractors and recommendations and bids for resealing cracks or possibly resurface.

### **Fire Safe Council**

Sherry Hawk- June has been a higher fire danger this year, absolutely no burning restrictions were early.

All programs offered by the El Dorado County Fire Safe Council still funded for:

Low income, chipping, seniors and hazardous tree removal. We will schedule the annual dumpster day for green waste on **Saturday, September 20<sup>th</sup> here at Gold Ridge.**

Gary Scheppelman has agreed to take over the treasurer position to replace Pat Schoggins. We are talking about the greenbelt area of work in Gold Ridge, C-10, which is very steep and most likely needs hand crews, considering using CCC as a possible option.

Fire Wise Certification- needs documentation of member's hours spent and/or money paid for defensible space clearing.

Greenbelt budget shows \$6800 spent on fuel reduction, to be corrected to move the expense to hazardous tree removal to be completed next week.

PG&E and CalFire have great fire safety presentations I would like to have a meeting and share via social media, TBD.
