New Business

Jack Mermod -C-10 Greenbelt work- We have \$33,200 remaining in the budget, this area has very thick timber and very steep, may need hand crews, I met with Evan from Cornerstone and looked at 37 acres of the section, it has 5 fire access roads that are overgrown. We want to do some roadside clearing and thin trees next to the road. The rate is typically between \$1,500 to \$2,000/day. They can use their 19" track chipper that can work the steep hillside, with their crew for \$4,000/day. Discussion.

Jack Mermod-motion to approve 5 days work total \$20,000 and possibly extend more days after inspection, second-Mark Weiner, all in favor: all directors -aye- motion passes.

Joan Fuquay-Recommendation to change money market accounts to CDs – As of the most recent reports on 6/30/25 GR total is approx. \$576,508, Operating \$226,175 and reserves \$350,333. We recently moved \$50,000 from operating funds and \$50,000 from reserve funds to money market accounts at US bank that are earning 3.56%.

Joan Fuquay-motion to approve move and close the \$10,129 operating funds from Umpqua to US bank # 2818 to add to the interest bearing account, and move and close the \$6,227 reserve funds from El Dorado Savings to the US bank account # 2834, second-Jack Mermod, all directors voted aye, motion passed unanimously.
