Notes from the Forest

Dominique Smith, Greenbelt Director



When the snow stops and the sun gets warmer, the greenbelt business comes to life, and this year has been no exception. My Assistants, Steve, and Sonny Steinbrecher, and I have been out meeting and speaking with neighbors for the past month or so, and it is one of our favorite reasons for working in the greenbelt. Nothing better than nice neighbors and beautiful forest walks!

The BEST news is how well a vast majority of you are keeping up with your personal "Defensible Space" requirements. If we do happen to mention something to you, PLEASE remember, our job is to be on the lookout for our entire neighborhood, and our concern is for all of us who live here in "Nature's Wonderland."

Our new automated "Client Request for Greenbelt Services" application is a huge success. Greenbelt requests are now coming directly to my inbox, which allows our crew to dispense with all the paperwork and time that it takes to go through the office to the field. According to our records, since we implemented this application in late April, 99% of your requests for service have been handled the NEXT DAY! We are very pleased with that.

On terms of actually getting to your trees is another story, and we hope you understand some of the dynamics 2022 is presenting us with, and we indulge your patience:

1. On average, the cost to the association to "fell and clean up" one 16" diameter tree, is quite expensive, especially if it is close to a structure. We have about 25 -30 trees on the list for removal.

- 2.) Due to COVID and the present labor situation, ALL our tree removal companies are running about 50 75 days behind schedule, because of limited staffing and the large amount of leftover damage from the CALDOR fire last summer. A forest fire in the area can further impact their schedules this summer.
- 3.) In our work we have noticed some property owners are placing trash and debris in greenbelt areas close to their property. Neither the greenbelt crew, nor our contractors, are prepared to remove this debris. THIS IS A PROPERTY OWNER RESPONSIBILITY!
- 4.) The loss of the association's large swimming pool last winter is our major concern, budget-wise, this year. Your Board is watching the construction costs of the pool re-make very closely. If there is a need, we will be required to move funds from one area of the budget to that project. This has not happened yet, but the County has placed a pile of new changes and restrictions for its approval of the new pool construction, and changes cost money.

Other than that, we are humming right along. We are awaiting final word on our U.S. Department of Agriculture matching grant, which at the present time, appears to be about \$280,000, which we are extremely excited about, as this will allow us to masticate and clear out a LOT of what we call the "deep greenbelt," which is a tangle of dry brush, ladder fuels, and trees.

We remain in touch with Sherry and the Fire Safe Council on an ongoing basis, and we share information coming in from many sources for the protection of our greenbelt and forest land.

I would also like to thank our employees, Tony and Bob who work in the greenbelts, help with maintenance projects, and generally work to keep things in good order. Their work, which often happens behind the scenes, is a valuable part of keeping our common and recreation areas in great shape. I appreciate seeing them out early in the morning or in the afternoon, demonstrating what working in service to others looks like.

Karen, our Office Manager, has had quite the year. From the Caldor Fire to an Eastern European computer hack, Karen has consistently supported both the Association and the Board. During the fire, Karen worked to ensure that our staff was paid and that our critical documents were kept safe. As we moved into our financial system redesign, Karen worked many hours to support the new system that has been set in place. Karen is also the first person that many people meet when they come into the Association, and she always strives to provide timely and accurate information. I appreciate the work that Karen does and her many years of dedication to our Association.

I would also like to thank our many volunteers who have stepped up to help make our association a better place to live and relax. Our volunteers have helped build the bocce ball court, helped to restripe the pickleball courts, provided music nights at the lodge, participated in the fire safe council, helped clean the greenbelts, cleaned and maintained the disk golf course, assisted with green waste collection, volunteered on committees, assisted with the conversion of our financial system, provided informational meetings for fire evacuation and many, many more things that, if listed, would create a 100 page newsletter. So, to all our volunteers, thank you! We are all stronger together.

Finally, for our new Board members, whoever they may be, you are joining a wonderful team and your life will be richer for it.

There is lots to do and enjoy! Pool fobs are on back-order and we are waiting for them to be delivered. Please know when the pool is opened we will have a list of members so you will be allowed in the pool if you are a member in good standing.

Late Fee Increase July 1, 2022

The CC&Rs provide that quarterly dues are deemed delinquent 15 days after the quarterly due date, A late charge not exceeding 10 percent of the delinquent assessment or \$10, whichever is greater, may be assessed.

Late charges have remained at \$10 through the first two quarters of this year. However, at the June 1, 2022, GRFPOA Board meeting, the Board of Directors approved increasing the late charges to 10% (\$10.70) of the delinquent dues assessment, beginning with the third quarter dues for July 1, 2022.

This late charge will be assessed on delinquent dues starting July 16, 2022. A daily interest fee of .03287671% will be charged on any outstanding balance 30 days from the due date (August 1). This daily interest rate will be applied each month on the unpaid amount.

Our annual election for GRFPOA Board of Directors is July 9, 2022. Ballots were mailed to all property owners on June 6. Members are entitled to ONE vote per lot, regardless of the number of members having an interest in the lot, **Be sure to follow the instructions provided with your ballot**

There are two openings on the Board. The candidates are Robert Newmeyer, Robyn Swift, and Marie Zandona-Harger You may vote for two.

Do NOT write any identifying information on the ballot, **Do NOT** sign your ballot. Once you have checked your choices on the secret ballot, place the ballot in the envelope marked "Inspector of Elections" and seal the envelope.

Place the sealed Inspector of Elections envelope into the envelope addressed to Gold Ridge Forest Insp. Of Elections, League of Women Voters of El Dorado Co., PO Box 863. Placerville, Ca. 95667. Seal the envelope.

On the blank line in the upper left-hand corner, SIGN your name under your return address which includes your lot number. (which is used as a separate identifier that entitles you to vote). If you fail to sign the envelope your vote is not valid and will NOT be counted.

You must mail your envelope to Gold Ridge Forest Insp. of Elections, League of Women Voters of El Dorado Co. Ballots must be received no later than 5:00 PM on Friday July 8, 2022.

Do Not Drop off your ballot at the GRF Office. It must be mailed to the Election Inspector. Do Not include your dues payment in any of the envelopes.

The ballots will be opened and counted by the League of Women Voters at the GRFPOA Lodge at the Annual Membership Meeting July 9, 2022. Winners will be announced at the Annual Membership meeting. **Come join us for a POTLUCK BBQ and learn the election results.**
