

Compliance Committee Update Marie Zandona-Harger

I would like to thank those members that have been recently contacted by the CC&R Compliance Committee regarding violations. Most of our members are very cooperative, and many times are unaware they have not followed the CC&R Rules and Regulations. Once informed, they work to bring their property into compliance, it is greatly appreciated by the board and your neighbors.

Most Common Complaints/Violations

- 1. Unsightly lots (accumulation of discarded items, tools, garbage, accumulation of personal property, machinery/equipment, trailers, etc.)
- 2. Barking dogs and other noise (including amplified music, disturbing the peace.
- 3. Modifying house/property without Board approval (decks, fences, temporary structures, sheds, additions/conversions, excavation, cutting trees greater than 10" etc.
- 4. Parking on unpaved areas/dirt areas of the lot (includes cars, boats, RV's, trailers, campers, etc.)
- 5. Inoperable vehicles on property.
- 6. Property owners not fire-clearing their properties.
- 7. Dogs off leashes/dogs roaming the neighborhood unattended, dog waste.
- 8. Parking on the roadways (causing vehicles to cross onto oncoming traffic).
- 9. Working on cars beyond an "expeditious repairs" time period, car maintenance outside of the garage.
- 10. Garbage: bears getting into trash, bears dragging trash.
