There is no law or disclosure required for marking property lines as part of a sale of property. I recommend making it a requirement as part of HOA packet for sellers to disclose property lines prior to sale.

Generator \$150, and cordless fogger to aerate (2) will spend less than \$600 and have it, it can be sprayed on skin, on surface for food prep, can also use at pool this summer.

It is currently used in all schools in the county.
