GRFPOA Going Green

Effective this month property owners will begin receiving their quarterly dues invoices (UNLESS YOU ARE ALREADY PAID-IN-FULL) and newsletters electronically, UNLESS YOU SPECIFICALLY OPTED FOR HARD COPY DELIVERY.

Why? Two main reasons:

This will save the association between \$8,500 - \$11,000 annually in staff, materials and mailing costs. Your Board believes these funds can be better spent elsewhere, such as in the greenbelt. It also reduces our association's use of paper supplies and reduces our carbon footprint.

This is part of an ongoing project to reduce staff hours and costs, install new financial software, and re-tool GRFPOA's billing system, website presence, and communications between the Board of Directors and our members!

Here in Gold Ridge, we were evacuated due to the Caldor Fire, worked through virtual meetings because of COVID, a huge snowfall in December, and then a serious ransomware attack requiring a complete computer system rebuild. Through it all, what has been highlighted, is how we help and take care of one another. Neighbors have shoveled driveways, removed trees that have fallen in the roadway, delivered groceries to those who can't get out, found time to laugh, found time to smile and found time to see that we often have more in common than we are different. 

Greenbelt: Working Hard to Keep our Properties Safe

We are gearing up for the upcoming summer months. We have been planning and talking with companies about green belt work, which will begin next month if the weather continues to cooperate. Plans include completion of the 100' defensible space in and around homes. Although this makes up only 50 of our 225 acres in GRF (20 acres around the lodge area and another 205), it is absolutely the MOST critical area of our green belt, as it is that which surrounds our homes.

Between our Green Belt Director and the Fire Safe Council, we can expect between \$188,000 and \$198,000 in grant funds this year. Our economic "burn rate" last summer was \$1,500 per acres, which will translate into another 127 acres or so cleared!

We have completed all the greenbelt areas with the exception of C-5 and C-1, which is where we will begin in 2022 after the defensible space areas are complete. A big Thank You to Joe Garrett and A Team Tree Services for their hard work.

We absolutely can use some volunteer workers in the Green Belt area to check out dead trees, assist with property line marking, coordinating projects such as firewood donations, and interfacing with the GRF Fire Safe Council.

Technology Update

As many of you are aware, Carol and Steve Steinbrecher, GRF property owners, have been working with the Board and office staff to upgrade and replace GRFPOA's hardware and software systems. This project has been going on since November and is now almost complete.

To date, new financial and staff payroll software has been installed, tested and is being used. GRF is now moving toward all-electronic transactions with our business partners, banks, and property owners. New "triple layer" hardware and software security has been implemented to protect our data. Property owners will have a variety of ways in which to pay their dues and other association fees. Newsletters and anything else GRFPOA is not REQUIRED to send via snail mail will be electronically sent to property owners in the future. The Board's ZOOM communications system has been completely upgraded to facilitate more interaction at board meetings.

We are happy to announce that GRFPOA collected over \$21,000 using our new Square system and credit cards. Our property owners have been asking for a credit card alternative and we listened. WE WILL NO LONGER BE ACCEPTING CASH PAYMENTS AS A REQUIREMENT OF OUR FIDUCIARY BOND.

The final portion of the project will be a rebuild of the GRFPOA website in order to give the Board the flexibility to reach out to all of us in many different ways. We anticipate project completion by the middle-to-end of June.

Best news is we have been able to save enough money in a variety of areas, which will mean the entire cost of the project will be "cost-neutral," and when completed should allow the association to run its business with annual cost savings of \$8,000.

New POA Packet

Gold Ridge has a new POA Packet that will be used when homes are sold in the Association. The document fee is now itemized and called the POA packet. This POA packet of documents has an itemized price for each document instead of having a single amount for all the documents needed when a home is sold. It adds clarity as to what is being purchased and the costs associated with each document. We have also raised the cost for a key FOB needed for the pool and tennis courts. The fee has increased from \$50 to \$75. This will apply to new homeowners. The transfer/statement fees remain the



Hack Attack

Like many other Americans and our companies, GRFPOA's internal computer systems were hacked two weeks ago. The attack originated in the Eastern European block and the hackers demanded an \$800 "crypto-currency" payment to their account, under threat of releasing all our personal information to the Dark Web, so the bad guys could get at it.

We do not tolerate or negotiate with hackers. We met with the EDSO's Computer Crimes Division and a well-respected IT security firm instead. We have taken care of the problem and added GRFPOA computer systems to a Virtual Private Network, which makes it almost impossible for hackers to reach inside our three-layer security ring. Additionally we have discontinued the use of the office@goldridge.org email and have replaced it with <code>grfofficel@gmail.com</code>. The EDSO is looking for the originators, but these guys are very hard to catch. Rest assured. Your information is safe.

Sherry Hawk, our Gold Ridge Fire Safe Council Director, is in the process of setting up a very important Community Preparedness meeting for either April 30th, May 1st or May 2nd of this year.

Steve Steinbrecher attended the "Pioneer Fire District" community preparedness meeting in February of this year, and he said, "It was a real eye opener for the community of Grizzly Flats. There were over 100 people and one County Board member present, and we learned a great deal about the CALDOR fire, as well as what to expect in the future." Steve said his major "take-away" from the meeting was the **critical importance** of the local neighborhood Fire Safe Councils in preventing future wildfires and damages to local properties.

At the present time Sherry stated the presenter would be Mr. Ben Gotts of the U.S. Forest Service, who is also a local Pollock Pines resident, so he has a vested interest in this subject as well.

Due to the importance of this meeting, the GRF FSC is trying to get the Pollock Pines Camino Community Center set as the venue, as the importance of this meeting to our entire community cannot be overstated.
