

August 28, 2024 Board Meeting Minutes

Meeting called to order by president, Jack Mermod at 6:11PM. Directors attending: Jack Mermod, Bill Simonson, Mark Weiner, Joan Fuquay and Chris Soule via ZOOM.

Previous Meeting Minutes Approval

July 23, 2024-approved with one correction to Finance Report, last sentence, "reduced by \$12,000".

Joan Fuquay-motion to approve July 23rd BOD meeting minutes, second-Bill Simonson, all in favor, motion carried.

Director Reports

Finance- Mark Weiner-2024 budget, we met for 2 hours last night working on the 2025 budget for next year, we went 2/3 through each line item. We will schedule the next budget workshop in September, request reports early from Wendy.

The next budget workshop board meeting is scheduled on Thursday, September 5th at 6:00PM.

Current operating balance is \$233,000, Reserves balance is \$270,000, over \$500,000 total. We are currently over \$72,000 this year, compared to last year at this time.

Greenbelt

Chris Soule-we have a list of hazard trees for our contractor, waiting for a break in hot weather to schedule.

Recreation

Jack Mermod- The pool will close on Sunday, September 8th, the last day of the season.

Fire Safe Council

Sherry Hawk-GRF has been awarded by RCD additional grant funds to work on C-13, 14, and the Recreation Area and Disc Golf course. They will also treat 3 other parcels north of GR on Sly Park Rd.

Programs still have funding available:

Chipping-free, hazardous tree removal can be free or up to 25%, low income, and senior program offering defensible space clearing. You can find them on the EDC website and a link for GRF website.

Community Wildfire Protection Plan- all county meetings scheduled locally in Pollock Pines on October 5th. A survey for all residents, Gold Ridge, Pollock Pines, and El Dorado County to participate.
