To help you prepare for your coming appointment, we have created the below checklist as a guide for what you should bring with you. If you believe you have any documents that could affect your taxes for 2025, and they are not listed here, please feel free to bring them as well or call our office during normal business hours.

- 1099 Forms for all IRA & Pension Distributions you received during 2025, as well as the amount of contributions you made.
- If you made any state or federal Estimated Tax Payments during 2025, please provide all amounts paid as well as when they were paid.
- All Interest Income and Dividend Income earned in 2025 (Forms 1099-Int and 1099-Div)
- All 1099-SSA forms detailing all Social Security Benefits you received in 2025.
- Any 1099-G forms you received detailing Unemployment Benefits or State refunds you received.
- If you are divorced and are either paying or receiving alimony , please provide the amount you received/paid in 2025.
- Brokerage statements detailing stocks, bonds, and other assets sold during 2025.
- If you sold any of your real estate holdings (home, rental, etc.) please bring a copy of your Closing Escrow Statement.
- If you own properties that you rent out, please bring a summary of income and expenses for each property.
- If you have an interest in an Estate, Trust, Partnership, or S-Corporation, please bring a copy of your schedule K-1.
- If you are self-employed, please bring a summary of all income and expenses for your business as well as any other information (EIN, Home Office information, Business address, etc.)
- If you bought supplies for work (books, markers, pencils, etc.) and were not reimbursed or had other job related expenses (continuing education, dues, subscriptions to journals, etc.), please provide a list with prices.
- If you used your personal vehicle for work, please provide the total miles you traveled during the year, the total number of business miles traveled, and all auto expenses (repair, insurance, lease payments, etc.).
- A list of all Medical Expenses you paid in 2025 and were not reimbursed for (X-rays, Dentists, Prescriptions, Insurance premiums, etc.)
- If you have an outstanding mortgage, please bring a copy of your 1098 Mortgage Statement.
- A copy of all property taxes paid in 2025.
- If you made any donations by cash, or donation (Goodwill, Salvation Army, etc.) please provide a summary and include any letters or receipts you received.
- If you made any improvements on your residence personally, or paid for a contractor, please let us know what work was done and all costs.
- If you paid for tuition please bring the 1098-T from the school (usually found online).
- If you experienced a loss of property (house, vehicle, etc.) in a presidential declared disaster, such as the Eaton Canyon or Pacific Palisades fires, please provide the following information:
  - Item
  - Cost or other basis
  - Amount of Insurance or other reimbursement received
  - Fair Market Value before loss
  - Fair Market Value after loss
