What is a property appraisal?

A property appraisal is an estimate of a home's value conducted for free by a real estate agent. You might get a property appraisal if you're selling your home and you want an idea of how much it could sell for.

What is a property valuation?

A property valuation gives you an exact figure of a property's value and is undertaken by a qualified valuer. Some situations require a property valuation, like formally calculating the equity in a property or property settlement.

Property appraisal	Property valuation
An estimate of your property's worth based on recent local sales & home features	A detailed report of a property's value in the current market
Usually conducted by a real estate agent	Conducted by a qualified valuer
Typically requested by potential vendors to get an insight into their home's position in the local property market	Typically required for property settlements, securing finance from a lender, calculating equity & in deceased estates
Will usually come at no cost	Usually costs between \$300-\$600 (may be covered by the lender)
Appraised value will not always be reflected in the property sale price or valuation	The official property value may not be reflected in the sale price
No legal standing with no guaranteed accuracy and should be treated as a guide for pricing	Can have legal standing
