## SHOT, KILLED & BUSTED!

### 1 Dead, 2 Shot & 3 Arrested in FBI Cocaine Robbery Sting Shootout

A gun battle broke out last Tuesday when FBI agents lured gun wielding gang members "...big goons with AK-47s..." to a warehouse on a ruse to rob up to 8 kilos of cocaine from a fictitious drug dealer.

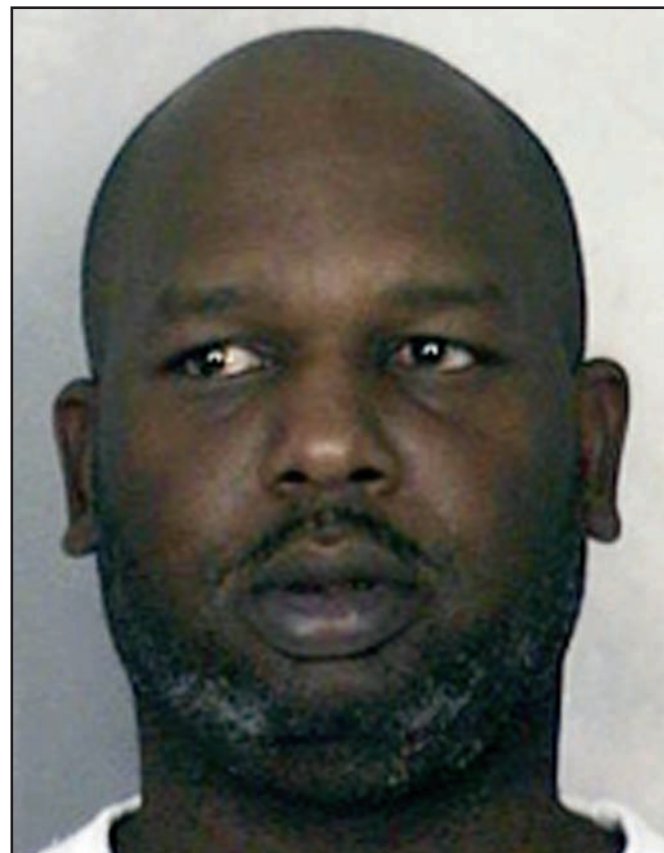
No agents or officers were injured in the melee. One offender lay dead and three others were in custody; two in the hospital and one in Palm Beach County Jail.

Shot dead; Cory Caldwell, 18 from Deerfield Beach. Pompano Beach residents, Anthony "Tony" Jackson and Michael "Mikey" Jackson were both

shot and placed under armed guard in Palm Beach area hospitals.

Frank Jackson, attempting to flee the scene, crashed his automobile and is being held in Palm Beach County Jail.

The FBI has been investigating gangs in Palm Beach County for some time and this incident is an offshoot of the ongoing operation. Using robbery, as well as other deceptive means to bring gang members to justice is a common tactic used by FBI and other law enforcement agencies.



Frank Jackson, attempting to flee the scene, crashed his automobile and is being held in Palm Beach County Jail. Two others were shot and taken to local hospitals.

##### 2004 Nissan Sentra Florida Tag "V21VDN"



Palm Beach County Sheriff's Deputies were involved in a traffic stop of the above vehicle in the 3400 Block of North Military Trail. The driver of the vehicle engaged a Deputy Sheriff in a struggle over a suspicious black bag and the Deputy became lodged in the passenger's front window as the vehicle sped away. The rear window was broken and shot out by Sheriff's Deputies as a result of the incident.

**The driver had been identified as David John Coleman. W/M, DOB 10/21/63 Brown Hair & Eyes.**

**He is 5'11 and weighs approximately 180 lbs.**

In publishing booking photos, the American Defendant intends to leverage the "shame" factor that has been historically associated with decreasing the incidents of criminal behavior.

In an article written in the USA Today in April of 2008, this theory was supported. It has been documented that the fear of being found out by one's community of peers acts as a deterrent to crime. Data exists that suggests as much as a 50% decrease in criminal activities when the concern of being published is real.

In developing the idea of The American Defendant newspaper we created relationships with several Florida law enforcement agencies and

our concept was enthusiastically endorsed.

Moreover, Crime Stoppers has endorsed the publication as a positive step in helping to publicize unsolved crimes and missing persons cases. It has been noted that once Crime Stopper content has been published and distributed, there has been up to an 80% increase in the apprehension of wanted individuals. Because of these arrests, the number of future violent crimes committed by captured individuals, although impossible to quantify, has been eliminated. This makes our communities safer and more productive.

## 10 YEAR OLD MURDER OF TERESA RUSSO

**The Palm Beach County Sheriff's Office, Violent Crimes Division, is Seeking the Public's Assistance in a 10-Year Old Murder Mystery of Teresa Russo.**

Teresa Russo was a 23 year-old, white female, DOB: 7/2/71. The victim was living with her family at 11833 Greenbriar Circle in Wellington, Florida at the time of her murder. Teresa was last seen on 2/27/95 at her place of employment, Barbizon Lingerie Store. Teresa was scheduled to work on this date from 2:30 pm until closing (around 9:00 pm). A security guard last saw Teresa as she was locking the front public entrance door of the business at approximately 9:00 pm. After work, Teresa was supposed to make the store's money deposit at a bank located across the street from the Outlet Mall, however never did. Prior to leaving work on 2/27/95, Teresa telephoned her parents at approximately 9:30 pm and told them she was going to be late coming home because she was going to take a friend home and get something to eat, however she never identified the friend.

On 3/2/95, Teresa's body was discovered in her vehicle in the parking lot of Scotty's Lumber, which was located on Military Trail between Okeechobee and Belvedere Road. Investigation revealed that Teresa had been shot multiple times while sitting inside her vehicle.

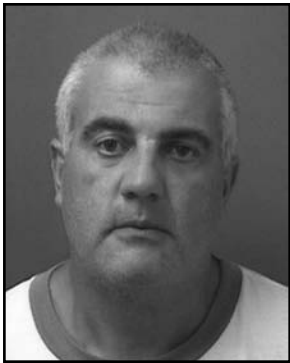

Currently, the investigation is focused on one person of interest and we are continuing to pursue active leads.

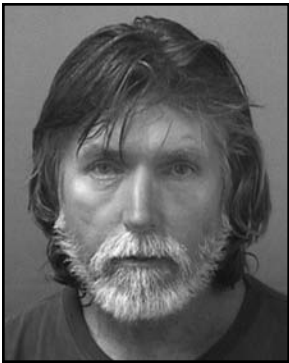

## SHOT, KILLED & BUSTED!

1 Dead, 2 Shot & 3 Arrested in FBI Cocaine Robbery Sting Shootout

A gun battle broke out last Tuesday when FBI agents lured gun wielding gang members "...big goons with AK-47s..." to a warehouse on a ruse to rob up to 8 kilos of cocaine from a fictitious drug dealer.

No agents or officers were injured in the melee. One offender lay dead and three others were in custody; two in the hospital and one in Palm Beach County Jail.

Shot dead; Cory Caldwell, 18 from Deerfield Beach. Pompano Beach residents, Anthony "Tony" Jackson and Michael "Mikey" Jackson were both shot and placed under armed guard in Palm Beach area hospitals.

Frank Jackson, attempting to flee the scene, crashed his automobile and is being held in Palm Beach County Jail.

The FBI has been investigating gangs in Palm Beach County for some time and this incident is an offshoot of the ongoing operation. Using robbery, as well as other deceptive means to bring gang members to justice is a common tactic used by FBI and other law enforcement agencies.

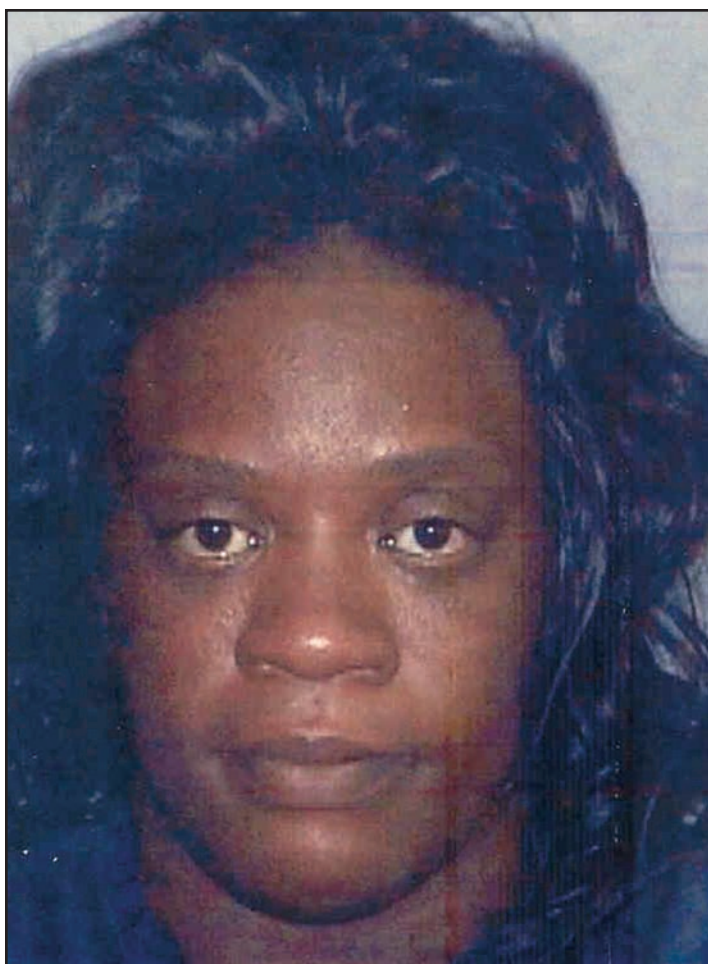

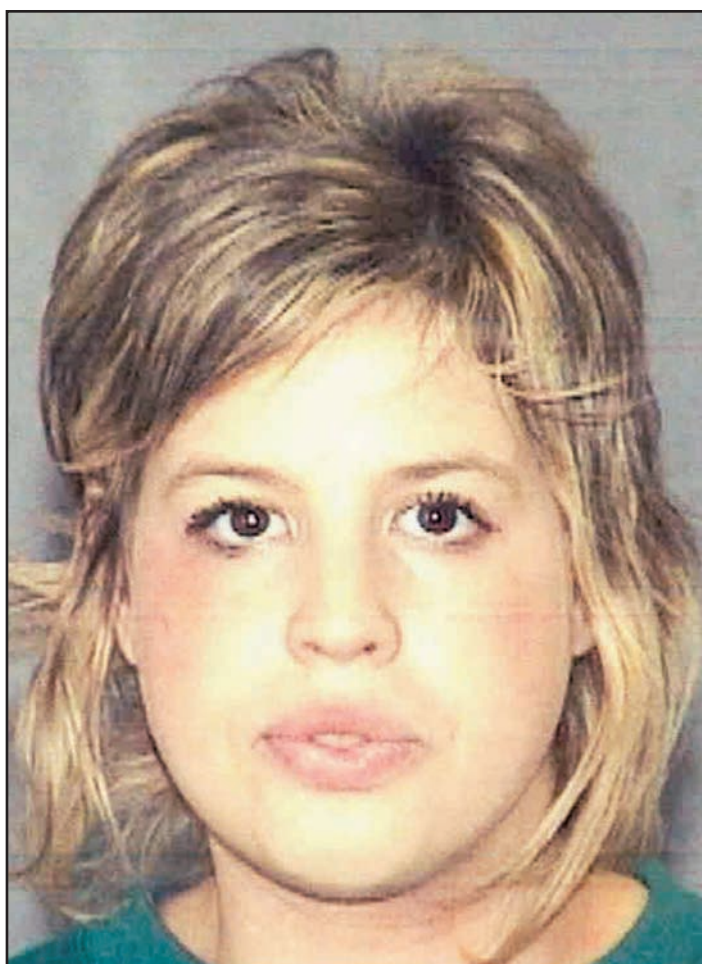
