



Risk Assessment

As in all clay target shooting sports, there is the possibility of cartridge deflection off trees, targets and other solid objects on the area of ground on a HunterQ Simulated Game Shooting Day.

Likewise pieces of clay targets (and even whole targets) may fall near or even hit the shooter. The use of protective shooting glasses is therefore absolutely required, as is the use of ear protection (defenders or earplugs) and the wearing of a hat.

Disclaimer

- I am over the age of 18 years old.

- I understand that photographs may be taken during the days shooting that may be used for promotional purposes. I will notify a member of HunterQ in writing if I do not wish for photos of myself to be used.
- I confirm I will be wearing the correct clothing and PPE for a days clay shooting (including shooting glasses, ear defenders and a hat).
- I am NOT prohibited from possessing firearms or ammunition under Section 21 of the Firearms Act 1968.

I understand and agree to the above statements.

I understand in the interest of safety, HunterQ will NOT allow guests to participate if INCORRECT clothing is worn and safety equipment is not worn (glasses, ear defenders and a hat).

I understand the inherent risks involved in recreational sport shooting and by my signature, hereby RELEASE, WAIVE and DISCHARGE, HunterQ, its employees, officers and volunteers from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury including death, that may be sustained by my person, or to any property belonging, while participating in a HunterQ Simulated Game Shoot
