 - B. The risk of injury from ammunition shot from other guns;
 - C. Walking in rugged country, including encounters with wildlife, animals and insects;
 - D. Inclement weather conditions;
 - E. The risk of injury from riding on an all terrain (ATV) or any vehicle used off road; and/or
 - F. The risk of injury from the use of tree stands.

I understand the risks, hazards, and dangers as described above and have had the opportunity to discuss them with the members of <u>The Great Northern Sportsman's Club Inc.</u> I understand that these activities may require good physical conditioning and/or degree of skill and knowledge. I believe that I possess the physical conditioning and/or degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks. I AM VOLUNTARILY USING THE SERVICES OF the <u>Great Northern Sportsman's Club Inc.</u> WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, OR DEATH.
