- The applicant must be a lineal descendent of a Cherokee who is listed on a Cherokee Roll taken prior to 1925, or any other legal document proving a direct Cherokee line, **AND** must meet at least <u>one</u> of the following requirements:
- A resident of the State of Alabama.
- A Cherokee by blood/lineage, living or deceased, with ties to Alabama
- This application must be accompanied by:

 a. Documentation verifying a) direct
 blood/lineage documented Cherokee, or b)
 documentation to verify a direct blood/ lineage line already on file in the tribal office for a citizen of CTNEAL.
- b. A non-refundable application fee; and
 c. A passport-size photograph
- c. A passport-size photograph.

All documentation must comply with requirements established by CTNEAL. A citizen may not belong to more than one tribe, band or group.

If documentation is not complete, the application will be returned to provide an opportunity for you to supply the missing documents.
