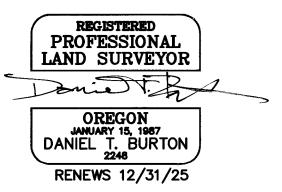

PLAT NOTES

- 1. THIS PLAT IS SUBJECT TO CONDITIONS OF APPROVAL AS STATED IN THE CITY OF SANDY PLANNING FILE NO. 24-004 MHLD.
- THIS PLAT IS SUBJECT TO A TREE PROTECTION COVENANT RECORDED AS DOCUMENT NO. 2023-018349, AND REVISED TO UPDATE LOT NUMBERS PER DOCUMENT NO. 2024-010314 CLACKAMAS COUNTY DEED RECORDS. THE INTENT IS TO LIMIT REMOVAL OF TREES WITHOUT CITY APPROVAL.
- 3. THIS PLAT IS SUBJECT TO A PGE EASEMENT PER DOC. NO. 2022-044835. THIS IS A BLANKET-TYPE EASEMENT, OVER "EXISTING CONSTRUCTED AND/OR TO BE CONSTRUCTED" SYSTEMS, AND CANNOT BE PLOTTED.
- 4. LOTS 10 AND 11 DO NOT HAVE VEHICULAR ACCESS TO TEN EYCK ROAD.
- THESE LOTS WERE APPROVED THROUGH A MIDDLE HOUSING LAND DIVISION AND CANNOT BE FURTHER DIVIDED. THE APPROVAL OF THE LAND DIVISION WAS GIVEN UNDER ORS 92.031.
- 6. THE RESULTING LOTS CANNOT CONTAIN AN ACCESSORY DWELLING UNIT.
- 7. NEITHER AN HOA NOR RECORDED CC&R'S CAN PROHIBIT MIDDLE HOUSING LAND DIVISIONS.

NARRATIVE

THE PURPOSE OF THIS PLAT IS TO SUBDIVIDE AND REPLAT LOTS 1 THROUGH 9 OF TEN EYCK RIM, PLAT NO. 4704. THE BOUNDARY RESOLUTION IS PER SAID PLAT OF TEN EYCK RIM, CLACKAMAS COUNTY PLAT RECORDS, PLAT NO. 4704. THE BASIS OF BEARING IS ALONG THE SOUTH LINE OF TEN EYCK RIM AS SHOWN.



SURVEYOR'S CERTIFICATE

I, DANIEL T. BURTON, DO HEREBY CERTIFY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS THE LAND REPRESENTED ON THE ATTACHED PLAT, BEING A REPLAT OF TEN EYCK RIM, CLACKAMAS COUNTY PLAT RECORDS, SITUATED IN THE NORTHEAST ONE-QUARTER OF SECTION 13. TOWNSHIP 2 SOUTH, RANGE 4 EAST OF THE WILLAMETTE MERIDIAN IN THE CITY OF SANDY, COUNTY OF CLACKAMAS, STATE OF OREGON, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE INITIAL POINT, A 5/8" IRON ROD WITH YELLOW PLASTIC CAP MARKED "ACS&P 503-668-3151" AT THE NORTHEAST CORNER OF TEN EYCK RIM; THENCE ALONG THE BOUNDARY LINES OF SAID TEN EYCK RIM PLAT THE FOLLOWING COURSES: S25°29'00"W 204.96 FEET TO THE SOUTHEAST CORNER THEREOF; THENCE N77'01'00"W ALONG THE SOUTH LINE OF TEN EYCK RIM 253.58 FEET; THENCE NORTHWESTERLY, ON THE ARC OF A 20.00 FOOT RADIUS CURVE TO THE RIGHT, THROUGH A CENTRAL ANGLE OF 118'30'00", AN ARC DISTANCE OF 41.36 FEET (THE LONG CHORD OF WHICH BEARS N17°46'00"W 34.38 FEET), TO A POINT OF TANGENCY ON THE WEST LINE OF TEN EYCK RIM; THENCE N41°29'00"E ALONG SAID WEST LINE (AND THE EAST RIGHT OF WAY OF TEN EYCK ROAD) 194.08 FEET TO THE NORTHWEST CORNER THEREOF; THENCE S77'01'00"E ALONG THE NORTH LINE OF TEN EYCK RIM (AND THE SOUTH RIGHT OF WAY OF HOOD STREET) 222.91 FEET TO THE INITIAL POINT; CONTAINS AN AREA OF 50,778 SQUARE FEET (1.17 ACRES), MORE OR LESS.
