Every day, our law enforcement officers stand on the front lines, sacrificing their safety and well-being to protect our families and communities. Yet many people don't realize that when a New Jersey State Police employee faces suspension — often related to an underlying substance abuse or mental health issue — their health benefits are terminated within just **14–30 days**. There is no appeals process for these suspensions, leaving officers and their families without access to essential medical care, counseling, or rehabilitation when they need it most.

Our mission is simple but urgent: **We provide financial assistance for health expenses so these brave men and women — and their families — do not lose access to care during some of the hardest moments of their lives.** We help bridge the gap by covering COBRA payments and essential health-related expenses for up to three months. This vital support allows officers to receive treatment, counseling, or rehabilitation — addressing the root cause of the issue and giving them a chance to recover, heal, and return to service stronger than before.
