

**RELEASE, WAIVER, INDEMNIFICATION, HOLD HARMLESS, AND ASSUMPTION  
OF THE RISK AGREEMENT**

WHEREAS, in consideration of participation in events hosted by or events the team participates in, NW INDIANA SMOKING CLAYS INC.. events (“NWISC”) and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Undersigned agrees to the following:

The Undersigned hereby acknowledges and agrees to have voluntarily participate in (“NWISC”) evens. It is understood and acknowledged that participation in shooting events in which others, as well as the Undersigned, are engaged in shooting activities involves inherent extreme hazards, dangers, and risks, including severe bodily harm or death. The Undersigned represents that he/she is physically able, emotionally stable, and fully competent to participate in shooting activities and that he/she freely, knowingly, and voluntarily assumes the risks of participating in such activities, including the risks of property damage, bodily harm, and death.

The Undersigned acknowledges, understands, and agrees to follow the rules provided to him/her or to his/her team for (“NWISC”) and all the rules of the host club.

The Undersigned affirms that he/she has and will refrain from being under the influence of alcoholic beverages, drugs or medications that might impair judgment prior to, and during, shooting sports activities. Further, the Undersigned affirms that he/she understands the possession and influence of unlawful drugs is expressly prohibited by the Farm Team, and that any person(s) who, strictly by our observations, appears to be under the influence of alcohol or unlawful drugs or emotionally unstable, shall be removed from the team and denied the ability to participate in any shooting activities.

The Undersigned affirms, under penalty of law and perjury, that he/she can legally possess or rent a firearm and that he/she has no criminal or mental background that restricts the Undersigned from such possession.

The Undersign acknowledges, understands and agrees that during (“NWISC”) activities that participants, volunteers, spectators staff, and others may drive or ride on golf carts, all-terrain vehicles or other vehicles to facilitate movement around facilities and courses. The Undersigns acknowledges and agrees that such vehicles involve an inherent extreme hazard, danger and risk including severe bodily harm or death. The Undersigned represents that he/she is physically able, emotionally stable, and fully competent to participate in operating or riding on

such vehicle and that he/she freely, knowingly, and voluntarily assumes the risks of participating in such activities, including the risks of property damage, bodily harm, and death.

The Undersigned acknowledges that certain ammunition is restricted during competitions and that he/she may not use steel or aluminum case, armor piercing, steel core, incendiary, tracer, or reloaded ammunition outside of manufacturers' specifications. Each discipline of shotgun shooting may have other restrictions on the ammunition that may be used, and the Undersigned agrees to adhere to those restrictions. If such is used, any damages resulting from such use may be billed directly to the Undersigned.

In addition, the Undersigned does for himself/herself, and on behalf of his/her heirs, executors, administrators, officers directors, owners, partners, agents, brokers, employees insures, and assigns, hereby releases, acquits, indemnifies, and holds harmless ("NWISC"), and its heirs, executors, administrators, trustees, officers, directors, owners, partners, agents, brokers, employees, insurers, assigns, and all other related persons, entities, affiliates, predecessors, and successors, from any and all claims, actions in law or equity, causes of actions, demands, rights, damages, costs, loss of services, expenses, and compensation whatsoever arising from any damage to property, injury to person, or death, (whether predicated upon negligence or otherwise) in connection with participation in any ("NWISC") activity. The Undersigned takes full legal and financial responsibility for any damage or harm to himself/herself, guests, if any, and for damages or harm to other individuals on the premises, rental equipment, or facility equipment that is a result of the actions of the Undersigned.
