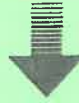

## **RECYCLABLES & TOWNSHIP INFO**

### **RECYCLABLES PICK-UP DATES:**

**December 8 & December 22**

If the recyclable date falls on a Monday holiday, the pickup will be on the following Saturday. Recyclables should be put out the night before, after 4:30 PM. In the Gettysburgs, please place them in the walkway between the cars near the street **and keep them outside, rain or shine.** If recyclables are not picked up, call (800) 488-6242.

**Please follow these rules:**

### **DO NOT PUT RECYCLABLES IN PLASTIC BAGS. USE YOUR RECYCLE BINS.**

**RECYCLE ONLY:** Aluminum cans, clean glass bottles and jars, steel and tin cans, plastic bottles with a #1 or #2 on the bottom, newspapers, corrugated cardboard (boxes must be flattened and tied), and mixed paper (magazines, paper, and junk mail).

**ITEMS NOT FOR RECYCLING: PIZZA BOXES, STYROFOAM, ELECTRONICS OR BATTERIES, SHREDDED PAPER, CERAMICS/DISHWARE, PAINT, POTS & PANS, OR PLASTIC BAGS.**

Recyclable buckets can be purchased at the Old Bridge Town Center for \$10.00. New residents (within a year of occupancy) can get them free, if available.

Do not put recyclables in the garbage as there are strict rules about this from the State EPA. Garbage collectors are not allowed to pick up recyclables so please be aware of this.

**White Appliances (microwaves, refrigerators, dishwashers, or stoves):**  
**Schedule pick up for these items at Old Bridge Recycling (732) 721-5600 Ext. 6107 and they will advise of the pickup date, cost, and procedure.**

## **IMPORTANT UPDATE**

**MAINTENANCE FEE:** The current maintenance fee is **\$215** since July 1, 2025. It is due the first of each month. No statement is sent unless it has not been paid by the 15<sup>th</sup>, at which time a \$25. late fee is charged. The check must be **received in the Office by the 15<sup>th</sup> of the month to avoid the late fee.** Do not post-date your check.

**If you are still writing a check for the maintenance fee, please make sure your unit address is on the check and print the amount very carefully.**

Call the office and leave a message if you are having difficulty in paying your monthly maintenance fee.

### **GARBAGE PICKUP INFORMATION**

The garbage pickup days are **TUESDAYS** and **FRIDAYS**. If either day falls on a holiday, then garbage will be picked up on the following pickup day.

### **NATIONAL PEARL HARBOR REMEMBRANCE DAY**

Each year on December 7, Pearl Harbor survivors, veterans, and visitors from all over the world come together to honor and remember the 2,403 service members and civilians who were killed during the Japanese attack on Pearl Harbor in Hawaii on December 7, 1941. A further 1,178 people were injured in the attack, which permanently sank two U.S. Navy battleships (the **USS Arizona** and the **USS Utah**) and destroyed 188 aircraft.

Every year, remembrance events are held at the Pearl Harbor National Monument, culminating in a commemoration ceremony on Dec. 7.

On Pearl Harbor Day, the American flag should be flown at half-staff until sunset to honor those who died as a result of the attack on U.S. military forces in Hawaii. Pearl Harbor Day is not a federal holiday – government offices, schools, and businesses do not close.

## **HIGHLIGHTS OF THE NOVEMBER 2025 CVA MEETING**

### **Trustee James Nolan, Regulatory & Compliance:**

Jim welcomed all to the meeting and was the moderator. A salute to the flag was conducted including a moment of silence for the sick, suffering, essential workers, and those serving in the Military. The next open CVA meeting is Thursday, January 15, 2026. The minutes of the last meeting were read and accepted. There will be two question and answer sessions: one after the treasurer's report and one at the end of the meeting. We will have the last round of nominations for the new board at this meeting. Maintenance will examine the complex for any remaining Federal Pacific panel boxes and they will be repaired. All air conditioning units should be removed by now. Sadly, one of our residents passed away suddenly this morning.

**Pres. Maureen Doloughty:** We had a wonderful Halloween party. Everyone had a great time. Attached to the Treasurer's Report is a matrix outlining what the Association and Unit Owners are responsible for maintaining. Do not park in the curb cuts outside of the office and library areas. Make sure you have a parking sticker on any vehicles you park here. If you use the clubhouse for any activity, ensure everything is put back correctly and the carpets and tables are cleaned. The Resident's Holiday Luncheon will be held on December 7. Cost is \$10 per person. There is no December open CVA meeting. No newsletter in January, but the calendar will be available in the office lobby.

**VP Ken Rigatti:** It was necessary to replace two stationary bicycles. Previously, all equipment was purchased by donations from unit owners. We have already purchased the two bikes but are asking for any donations you would like to make. The new pool cover has been installed. The New Year's Eve party is planned. Two ticket price options: Dinner & DJ - \$30. DJ only: \$15. Same DJ as last year. Seven streets are left to be sided and should be completed in approximately two years.

**Treasurer Patricia Smith:** Treasurer's report for October was presented and accepted as read. An explanation of several the various accounts used by the CVA was explained to attendees.

**Trustee Rich Kubian:** Fall clean-up was started today and will continue tomorrow. Photos were shown of wipes and paper products that were snaked out of the main sewer line on Oklahoma and Haven. If you get a live Christmas tree that can be planted, do not throw it away because it may be able to be planted somewhere else. Call the office.

**Trustee Jeff Pantalas:** Looked through the whole Village for addresses with air conditioning units in the windows after October 31. Letters will be sent to the owners and a fine may be issued. Check the back of your unit to ensure you have a sticker number on the back of your building.

## **HALLOWEEN PARTY 2025**



### **Footsteps in History by CVA Trustee James Nolan Episode 28 – December 2025 – Battle of Shiloh - "Hope Springs Eternal"**

The Battle of Shiloh was a key battle of the American Civil War fought in southern Tennessee. On the first day, April 6<sup>th</sup>, 1862, Confederate forces launched a successful surprise attack on Gen. Ulysses S. Grant's Union army, but on the second day were pushed back, after Union reinforcements arrived. The battle was considered a strategic Union victory but came at a tremendous cost, with a combined total of over 23,000 casualties, which shocked many individuals on both sides. During that first day, fortified by blazing artillery, Confederate officers launched wave after wave of soldiers against the Union lines, but by sunset, Confederate General Albert Sidney Johnston was dead, ammunition was low, and the men were exhausted. The Confederates had sustained 8,000 casualties, while Union forces had 7,000 men killed, 3,000 captured, and 10,000 who were afraid to fight.

Union General William Tecumseh Sherman found Grant under a nearby Oak tree, in pain from an earlier injury, holding a lantern and chewing a cigar. "Well Grant, we've had the devil's own day, haven't we?" "Yes," replied Grant with a drag on his cigar. "Lick 'em tomorrow tho." Of note here is that despite any adversity, even in tough times, tomorrow always brings hope, hence the proverb, "Hope Springs Eternal."

## FROM THE BOARD

### **SEWER BACKUP PROBLEMS**

If there is a backup in the toilet in your unit, it is the policy of the Cheesequake Village Association that you **first call the office** – or the emergency number after hours ---  
**(732) 425-2011.**

We have a full-time Maintenance Staff and someone is on call 24-7.

A member of the Maintenance Staff will try to clear the obstruction. If the obstruction is in the main sewer line, the staff member will call someone such as A-General to clear the obstruction and the Association will pay for the expense. **If you, as a homeowner, call a plumber without allowing the Association to try to resolve the problem, the Association will not pay for that cost.**

This applies only to toilet backups, not sink or washing machines. Nothing but toilet paper goes down the toilet, that is: NO GREASE, NO WIPES OF ANY KIND, NO RAGS, NO PAPER TOWELS OR KLEENEX AND NO DIAPERS. **If it is determined that any of these items come from your condo, you will be responsible for the repair costs.**

Do not use baking soda and vinegar in your drains. It has been proven to cake up similar to powdered detergents. ZEP and PEQUA, available at Home Depot, are the alternatives to use.

### **KEYS IN THE OFFICE!**

It is important to keep a set of your house keys or your security keypad code at the office in case of an emergency where entry into your unit is necessary. The keys are kept in a secure file cabinet in the office. If entry is needed, only a Board Member and a Maintenance member would enter.

## **REMINDERS**

**SELLING YOUR UNIT:** If you are selling your unit, it is **mandatory** that you contact the office to inform us of the sale. There is paperwork that needs to be completed and the unit's files in the office need to be updated.

**OVERGROWN BUSHES & PLANTS:** Your gardens are in full bloom. Please trim the flowers and bushes below your front windows and along the walkways. The Fire Dept. requires it in case of an emergency where you have to vacate your unit.

Gas and electric meters must be free and clear from bushes growing around them.

Trimming around the outside air conditioning units is a must. The landscapers do not trim around these units to prevent any possible damage to them. So, please clean up these areas.

**ALTERATION FORMS:** It is imperative that Alteration forms be submitted to the Office for any renovations to the unit. We are required to keep updated records on all units in the Village. Alteration forms will NOT be accepted for electrical or plumbing projects without a copy of the electrician's or plumber's valid license and insurance attached.

**PARKING PERMIT STICKERS:** Every car parked in the Village **MUST** have a parking sticker. Bring your car to the Office with your license and registration. This is mandatory. If you receive a letter about getting a permit, you must reply within 10 days, or you will be fined.

**DOGS ON EXTENDED LEASHES:** Please be mindful of other people when using extended leashes for your dogs or cats. Your neighbors can easily trip on them. Better yet, try not using them at all because Old Bridge rule allows for only 6 foot long leashes!!

**DOG & CAT OWNERS:** Dog droppings are still an issue. By law, you must pick up after your pet. If you are observed not picking up after your pet, you will be fined. Please do not walk your pet behind or on the side of other units since you are intruding on the privacy of

other residents. **PICK UP AFTER YOUR PET—IT'S THE LAW -- DON'T DISPOSE OF THE BAG IN THE SEWER OR SOMEONE'S TRASH BIN**

### **WORK ORDER REQUEST**

Please be patient after making a work order request to the Office. Our Maintenance Staff takes care of emergencies first and all other work is done in a timely manner.

**COMPLAINTS & GRIEVANCES:** If you have a complaint or problem with your unit, you must call the Office. If you have a grievance, please submit it in writing to the Office, attention Grievance Committee. It must include your name and address, or it will not be considered for action. **CHANGES IN UNITS:** As equipment has been changed (Ex: Furnaces, air conditioners, windows), new situations have arisen. When contractors add or change equipment, be advised that these changes created by your contractor are your responsibility and must be maintained by you and be added to your insurance policy. You must apply for an alteration permit from the CVA and from Old Bridge Township before making changes to your unit. Failure to do so will generate a fine.
