#### Minister's Message

"Thus says the Lord, 'I am about to do a new thing; now it springs forth, do you not perceive it?"" (Isaiah 43:19) "And the one who was seated on the throne said, 'See, I am making all things new."" (Revelation 21:5a)

When Benji was four, his mother thought he was old enough to hear the truth about Jesus. She sat him down and, using language he could understand, described the mystery of sin and redemption which is revealed in the Christian narrative, from incarnation to resurrection. When she had told Him just how much Jesus did and gave and suffered for humankind, Mom said, **"Now Benji, would you like to have Jesus in your heart".** 

Wise beyond his years, he thought carefully before answering, "No. I don't think I want that responsibility."

Benji's response begs a question for all of us who have aligned ourselves with a community of faith that self-identifies as disciples of Jesus. If Jesus is the physical incarnation of God who makes all things new, what is the burden of responsibility for those who call ourselves 'Christian'? Memories of how it used to be can be seductive, especially if the recollections are rosy compared with the challenges we face in the present circumstance. In my experience, being church used to be a lot easier. It has always required hard work and a measure of sacrifice, but the results were usually positive and the benefits came easier. Remember the days when pews were filled and families wanted to give their kids the benefit of a Christian education? Choir members and I, with a few others, enter the church on Sunday mornings by way of the back stairway. That takes us past the large photo of another Sunday, not that long ago, when the sanctuary was standing room only. Then, with that graphic reminder of how it used to be, we enter the sanctuary to worship with a fraction of that number.

The responsibility of being church is the same or harder than ever, but the results may disappoint. I write this not as an invitation to discouragement but to inform the perspective with which you read the following reports and messages. Here is a summary of the ministry we have shared during the past year, and of what we have accomplished together. Even with the lingering effects of the pandemic, we have endeavoured to be a church that demonstrates genuine caring for all our members and adherents. We have provided faithful witness and service to our community and beyond. With our special services at Easter, Reconciliation Week and Remembrance Day, we offered our neighbours experiences of timely and meaningful spiritual enrichment. With our partners, we provided programs for children, youth and seniors. The new lights, piano and improvements in technology have enhanced our sanctuary as a venue for worship and also for concerts and other activities.

The financial statements describe how we are meeting the challenge of financial viability at a time when many churches are drowning in deficits. With the arrival of a fulltime minister, that challenge will be even greater but your responses to the Stewardship Program suggest it is a challenge you will meet.

As tempting as it may be to long for those remembered 'good old days', we worship and serve One whose very nature is to make all things new. These reports demonstrate our willingness to be partners with God in the new things already begun. We never know what the future holds, for the church or for any of us, but we can be sure of this: God is with us. If we accept the responsibility that worried Benji, the next chapter in the life of Wellington United Church will be both new and good!

This congregation will always have my sincere gratitude for the privilege of sharing ministry with you and I look forward to seeing all the wonderful things that you and your new minister accomplish together, by the grace of God. (Rev.) Ed Bentley

### WORSHIP & PASTORAL SUPPORT COMMITTEE 2023

A lot of work was done in the Sanctuary in 2023 to add to the beauty of our space, to make it safer, and to better equip us to video our services for viewing by those worshipping from home. The old light fixtures in the sanctuary were replaced with new hanging fixtures, track lights and sconces which are stunning. Exit lights were also installed and the electrical wiring updated. A new projector and video camera were purchased and a new media booth is nearing completion. A new Clavinova electronic keyboard with much greater capabilities was purchased for the sanctuary. We hosted three very successful concerts this fall which helped to offset the extra cost of the Clavinova. These improvements were made possible by the generous donations, both public and anonymous, of members of our community of faith. We are most grateful for these very generous gifts.

The Decorating Committee worked diligently to fill the front of the sanctuary with special flowers at Easter, decorations at Thanksgiving and poinsettias and decorations at Christmas. Much thanks to them and to all who contributed to the costs of the flowers, and to those who loaned their nativity scenes to decorate the windows. Our sanctuary, while always appealing, was festively beautiful.

Our Sunday morning services are enhanced by the many volunteers who act as greeters, ushers, readers, projectionists and videographers, coffee hosts, and guardians of our building. Thank you for your caring contribution and I encourage more of our church family to step forward and volunteer. We are especially in need of people to become familiar with the running of the projector and the video recorder.

We celebrated communion on New Year's Day, Palm Sunday, World Wide Communion Sunday, the first Sunday of Advent, and New Year's Eve.

We held a special service in September with guest Sarah Tsawentehs Brown-Dunkley who spoke thoughtfully and sincerely about Truth & Reconciliation.

There were two special happenings which brought joy to my heart - one old and one new. How thrilling it was to hear the sound of children laughing, running, singing, praying, doing crafts, and learning as the Kids Can Camp children enthusiastically occupied the sanctuary and the basement on their days here. This initiative of Bloomfield and Wellington United Churches, the Wellington Pentecostal Church and Storehouse Foodbank welcomed children from throughout the County and was widely supported by many County businesses and residents. The other event was our traditional Christmas Eve candlelight service which because of Covid and weather we had been unable to host for several years. The Christmas story, the music, Rev Ed's message, and the candlelight brought both joy to the heart and a tear to the eye of many in the congregation.

### **Pastoral Care (Norma Griffiths)**

A team of six church members plays an important role in keeping approximately 30 shut ins,orfolks unable to attend regularly, up to date with church news and more importantly compassionate friendship. Many of these recipients are totally housebound or in long term care facilities and the visits are truly valued by them. The minister and team work closely together to offer this support and this is all done confidentially. Examples of what the team has done in addition to visiting, is driving them to appointments, offering meals, driving them to church functions and helping in various other ways as the need occurs.

A card ministry is part of the work as well and Linda Giglio is advised of cards to be sent out including: Sympathy, Thinking of You and Get Well. A prayer group is also advised of names to be prayed for. As two of the team have recently moved away we really could use more members.

### Fellowship and Faith Committee

In February of 2023, the Faith Development Committee was expanded to include Fellowship. With this came the welcome addition of Lynn Ward as a committee member and active leader in children's programming. Prior to this point in time, Lynn Ward ran (amongst other things) a very successful Messy Church event on an early Friday evening in the church auditorium. It was a multigenerational event with kids, families and older folks enjoying games and food.

- In March, a joint bible study group, led by Rev Cathy Duggan and Rev Ed Bently took place in Bloomfield, Consecon and Wellington United Churches. This was well attended and appreciated.
- In July we introduced our colourful "Talk to Me" Mugs with the hopes of helping strangers or new comers feel welcome and make it easier for us to get acquainted. It seems to be working.
- In August, under the energetic leadership of Rev Cathy Duggan and Lynn Ward, we hosted a
  fun filled week of Kids Can Camp. Close to 30 children attended the free half day program
  which provided snacks and meals, many sponsored by the community, as well as indoor and
  outdoor games and activities. It was a HUGE hit. As a result, full day programs continue to be
  offered, free of charge, registration required, on subsequent PA days. This is a wonderful
  service to our community. Feedback from parents and families is very positive and they are
  grateful for this program.
- Good things come to those that wait. This summer saw the very welcome addition of Diane Mills and Alyson Cranshaw to the committee. I am grateful for their continued contributions of input, ideas and help.
- In September, we provided a number of ideas for secular and nonsecular activities to the congregation and solicited feedback. While the response was underwhelming there were some ideas which we may circle back to in the new year.
- The cooler days of fall were the perfect backdrop of our first lakeside outdoor bonfire. October 27th was a cool, still evening with clear skies.Coffee, tea, hot chocolate was served and apples, popcorn and ingredients for making s'mores were provided. The bonfire took place in the parking lot behind the church and overlooking Lake Ontario. With the help of many volunteers everything ran smoothly. Approximately 40 or so people attended, including community members from Wellington and Bloomfield and everyone enjoyed themselves.
- We are considering hosting more throughout the year with earlier advertising in The Wellington Times and social media. While the new year is still very young, we already have several, varied events tentatively planned for the winter. Stay tuned. We are also very excited to have a full time minister on board in the not so distant future and look forward to working with him on new ideas and opportunities.

Again, MANY MANY thanks to Lynn Ward, Diane Mills and Alyson Cranshaw for their tireless work and support.

### OUTREACH COMMITTEE

This is my final report as Chair of the Outreach Committee for Wellington United Church. It has been a privilege to serve in this way as the Outreach Committee came together to figure out our role and responsibilities in this new church structure. While we have been a small committee in number of members, I am very proud of what we have accomplished.

Throughout the year we have continued to support the "Soup's On" initiative that was started last year at St. Andrews Anglican Church. Together the two churches have provided Soup, a bun and coffee and tea and a cookie to many people in our community who look forward to the time they can spend each Tuesday at lunch time with friends. Initiated originally as a way to provide a meal for people experiencing food insecurity, it has transitioned into a time of fellowship for anyone in the community.

In the spring when the warmer weather came, we moved into our hall and became "Coffee's On" to continue the warm fellowships. We even learned some new card and board games! Another partnership activity presented itself to our committee when the Prince Edward County Lions Club who meet in our hall, were asked to serve a breakfast of some sort at the Market held in our church parking lot each Saturday. Since the Lions did not have enough volunteers to take on this task alone, they approached both churches to see if other volunteers might like to share in the work and funds raised at the market. It was a great success with each group sharing in the work and each group earning \$ 1900.

In the late summer, another outreach opportunity presented itself when the church was asked to join with a couple of others to have an end of summer "day camp" for children and youth. Although the committee was not directly involved in this activity, we feel confident in reporting that this was definitely a wonderful outreach from our church and it continues to be so on days when students are off school because of Professional Activity days.

The subscriptions for **<u>Broadview</u>** magazine have been appreciated by those members of our community who have subscribed. We were able to ensure that three local library branches will now be receiving the magazine each month.

Perhaps our biggest undertaking was the organization of the "Indigenous Service" on the Sunday in September immediately preceding the National Day for Truth and Reconciliation (which will be Monday, September 30, 2024). Putting our heads together and seeking advice from others we were able to provide and very significant and moving speaker, Sarah Dunkley, on September 24, 2023.

AT our last meeting of 2023, we decided to donate \$500 each from our 2023 budget to a local, a national and an international charity –

-Locally, we chose <u>The Roc</u> which supports youth in Prince Edward County.

-The national charity we chose is True North Aid and the Misiway Nation.

-The international charity we chose is <u>The United Church of Canada, Philanthropy Unit</u>, Emergency Respose for humanitarian relief in Ukraine and Gaza.

I would like to close by sincerely thanking the members of the Outreach Committee. We have worked together to discern our role and carry it out as a team. Sincere thanks to Gail Dick, Paula Gray, Sharon Hopkins, Dayna Law and Lynn Ward.

**Mar** started the appraisal of lighting installation, electrical requirements etc which led to the discovery of a water leak in the Belfry.

We then approached alerted our property insurance provided and obtained an assessment of the costs. This took some time, also through the United Church of Canada we received a request to have our insurance put through their UC of Canada policy, this required us to get a new church replacement assessment completed which was accomplished.

The required documentation to the UC was submitted and we are still awaiting a response. The electrical work for the new lighting was started .

Mar/Apr the A/V platform was designed and started .

Barn Restorations were hired to start the repair on the Belfry.

We continued negotiations with our current insurance providers and we able to receive some payment for the repair.

**May/Jun** we had outside cleanup we hosted the County Blooms Flower show, the new retaining wall completed at back of church. July/Aug , Belfry completed, Church lighting completed,

The church At this time one of the local families lost their home in a devastating fire and the church was able to offer them the use of the commercial kitchen so they could continue to cook food for their business. (Adnan Mustafa of PapaGhanoush & MommHummus)

**Sept/Oct** Fire Extinguisher maintenance completed and approved, elevator maintenance completed ( furnace maintenance to be completed in Jan )

### MINISTRY AND PERSONNEL COMMITTEE

The Ministry and Personnel (M&P) Committee at Wellington United is responsible for supporting our staff, overseeing the relationship between our staff and the congregation, and supervising the working conditions, responsibilities and compensation of WUC staff. Much of the work of the M&P Committee relates to personal matters, and confidentiality is very important.

This past year has been a very busy one for our team. At the end of February, Reverend Bentley informed the committee of his intent to resign as our Interim Supervisory Minister at the end of May. After some discussion, it was determined that Reverend Bentley would in fact be prepared to stay on to oversee our Governance and Pastoral Care, and we would prepare a schedule of Pulpit Supply Ministers to conduct our Sunday services for June, July and August. Working in coordination with the Worship Committee and Reverend Bentley, we were able to secure the services of some wonderful Ministers including Malcolm Sinclair, Frank Hamper and Morag McDonald. In September, Reverend Bentley returned to conduct services on a weekly basis. He would be our Supervisory Minister until the end of 2023.

Annual reviews were conducted with both Marg McLeod, our Administrator and Andrew Tibbetts, our Accompanist. Both individuals continue to provide wonderful support to our congregation. Marg is entering her 8th year at WUC and Andrew his 7th. We want to thank them both for all that they do!

This past summer, Andrew requested a LOA to return to his studies for 4 months. Reverend Bentley was able to recommend 3 different individuals to fill in for Sunday services. Wellington United had the good fortune of enjoying Michael Faulkner, Ben Vandergaast and Jean Herrington. All of these talented musicians worked effortlessly with our Choir to provide exceptional music throughout the fall and Christmas season.

The one position that remains to be filled is that of Music Director, a position that has been vacant since 2020. This past year, we expanded our search tools by advertising in both print and social media. We will continue our efforts in 2024. We would also like to acknowledge Dianne Cranshaw for providing leadership and support not only to our Choir, but to all of the musicians who joined us in 2023.

We started 2023 with six (6) members, and today there are currently five (5) members of the M&P Committee including Lynn Ward, Karen Hurst, Pat Howard, Harry Marissen and myself. We saw the resignation of Gail Dick in May, and in October Lynn Ward resigned as Chair and I assumed the role. Lynn has remained on the committee. ### FINANCE COMMITTEE

#### **Finance Committee Report**

Our Finance Committee met regularly throughout the year, usually in the hours before our monthly Council meeting. These regular meetings and monthly financial reports allowed us to keep on top of the finances of the church.

Some items to note:

- The format of our monthly reports to council has been modified so that we can easily see month-by-month activity as well as progress against the budget.
- High-level monthly updates on operating revenue and expenses have been noted in the bulletin as well as e-blasts.
- In addition to Canada Helps, we are now able to accept e-transfers as another way of making on-line donations.
- We have returned to passing the offering plate as a giving opportunity.
- Our November Stewardship program proved fruitful in engaging people in both the work and the finances of the church.

You will note that the presentation of financial information to the wider congregation (eg. in this Annual Report) no longer details Ministry and Personnel expenses – a single line is all that appears. This is in accordance with new privacy laws in Ontario and supported by regional council. While congregational donations are the most significant source of revenue for our church, income from fundraising and building rental is also important. It's interesting to see how small amounts add up at the end of the year. The work of those who hull strawberries, bake pumpkin pies and knit slippers is much appreciated. We're also grateful to all who mysteriously appear to welcome user groups and ensure the building is safely locked up at the end of the day.

Many thanks to Ann Marie Jones, our Envelope Steward, who is assisted by Pat Howard. Linda Lavallee is our able bookkeeper. Kerry Burgess was our Treasurer until August when he began his well deserved retirement from the role.

# ENVELOPE STEWARDS REPORT

I have included the following table for information and review:

**Comparative 2023 totals.xls** – composite report. This report incorporates the category-by-category comparison between 2023 and 2022, a breakdown of the "others" list of all subsets of non-standard donations, and the overview of donations versus donor population.

The following should be noted:

- 1. The General/Local donations were up \$ 32,173.00 over 2022.
- 2. Seven designated funds were created for fundraising purposes in 2023, but the two largest were:
  - The "Belfry Repair Fund" which totaled \$13,420.00.
  - The "Clavinova Fund" which totaled \$13,073.00.
- 3. In 2023 approximately 75% of donations came from regular envelope/PAR contributors.

#### **Treasurer's Report**

The budget for Wellington United Church for 2023 was for operating revenue of \$133,250 and expenses of \$148,660 leaving a deficit of \$15,410.

As a result of the generosity of our congregation and the fact that we have not had a full-time minister at any point in the year, our operating revenue has exceeded our expenses in 2023 by \$35,026. While this is certainly good news, it's not without considerable contribution by many people who have pitched in to help with our ministerial void.

In addition to funding our day-to-day operations, significant donations have been made to special funds which have allowed us to purchase new technology, improve lighting in the sanctuary, repair our belfry tower, acquire a new piano, and run a successful children's camp. Donations have also added to our building fund and supported mission and service initiatives (including earthquake relief) within the national church.

The budget for 2024 represents a significant increase in ministry and personnel costs as we have included Rev. Doug's full-time salary from April 15 when he begins his time with us. As a result, our revenue requirements from congregational donations, facility rental and fundraising will be \$194,320, almost 30% higher than what we received in 2023 from these sources.

While this will be a significant stretch, it's worth noting that the total of all giving in 2023 (operating plus special projects/funds) was \$203,403.

Council has made the decision to present the budget as a balanced one, as opposed to a deficit, so that we can keep our aggressive revenue target front and centre throughout the year.

We have much to be thankful for and to look forward to in 2024 but will need to work together to make it happen. If you are not already on PAR, consider signing up to ensure we receive your gifts on a monthly basis. If you're already on PAR, might you be able to increase your monthly offering? Supporting events and organizations that use our space and engaging in fundraising projects are also ways of helping us achieve our goal. And if you know of any groups that would like to rent space, let them know that we are open for business.

Many thanks to all in our congregation who donate their time, talent and treasure to make this a vibrant faith community with a hopeful future.
