PUPPY PURCHASE AGREEMENT

Agreement of Sale and Warranty between the Breeder (listed above) and **YOUR INFORMATION** (hereinafter called the Buyer),

The Breeder agrees to sell the puppy described as:

The Breeders agree to deliver the Briard described above to the Buyer under the warranties, representations and conditions listed below:

1. See receipt for terms of sale.
2. Registration Limitations: Limited Registration. This puppy cannot be bred or shown in any breed conformation shows, but may be shown in agility, 4H, or other performance competitions.

2. The Buyer agrees to have the dog spayed/neutered not before 6 months of age and prior to one year of age.
3. The above named dog is a purebred Briard from a litter registered with the American Kennel Club and eligible for limited registration with the American Kennel Club.
4. The Buyer may use any Call Name they would like, as long as it reflects in a positive manner on the breed, breeders and individual puppy.
5. On the following date(s), the following veterinarians found the puppy in good health.

LIST OF VET VISITS

The puppy has had two sets of vaccinations. The vaccinations given were for Distemper; Hepatitis; Parainfluenza; and Parvo. A rabies shot will be required before 1 year of age depending on the state. In New Mexico the rabies shot is required at 6 months. In some states the rabies shot is required at 4 months. The first rabies shot will be for 1 year only. The following year, the puppy can be vaccinated safely to cover a three-year period.

6. The Breeders agree to provide a healthy puppy of sound temperament and free of genetic defects. The puppy has been tested for worms and treated accordingly, and has had all vaccinations commensurate with its age.
7. The puppy was wormed.

8. The Buyer acknowledges that the puppy described above is fully satisfactory. The Buyer is encouraged to have the dog examined by the Veterinarian of choice within 96 hours of taking delivery of the puppy, with the privilege of returning the dog to the Breeders within that time if the Veterinarian certifies in writing that the dog is not physically sound/healthy. Upon prompt return of the dog (at the Buyer's expense) with said certification, a full refund will be made. No refund will be made in the event of accident or negligence when in the care of the Buyer or his agent, unless the health of the puppy is restored to the original state of health at time of delivery.
9. The sire and dam of this Briard are certified (by OFA and/or PennHip) to be free of hip dysplasia, as are over 90% of their ancestry (See pedigree). The Buyer is encouraged to have this puppy certified at the age of two (OFA) or age of one (PennHip).
10. The Buyer agrees to take good care of the above puppy, including, but not limited to: proper diet; annual vaccinations, worm checks/treatment, heartworm preventative and other preventative health care; proper housing; good grooming, including the prevention and/or treatment of external parasites; extensive socialization and continued training; etc. Specifically:

- A. The Buyer agrees to socialize the Briard to constantly changing sights, sounds, stimuli and people to ensure confidence until the Briard is 18 months old.
 - B. The Buyer agrees to enroll the Briard in training classes within one month of purchase and continue classes intermittently until the Briard is 12 months old.
11. The Breeders agree to be available for help throughout the entire life of the dog and agrees to provide written instructions for the above. The Breeders maintain a continuing interest and pride in this dog and in his life. Any phone calls, letters, photographs will be much appreciated.
 12. The Buyer agrees that they will notify the Breeders of phone number changes, address changes, and email address changes as long as they own of the dog.
 13. The Buyer agrees that if for any reason the above dog cannot be kept, the dog and its AKC papers will be returned to the Breeders. If the Breeders are able to resell the dog, the Buyer will be refunded the resale amount less the cost of placing (veterinary, relocation, retraining, etc) the dog. The Buyer agrees that this dog will be not given, leased or sold to any animal shelter, humane society, pet shop, puppy mill, commercial breeder, dog agent, dealer or other wholesale or retail outlet. In the event of the Breeders' death, the Buyer agrees to contact the Briard Club of America for help in placing the dog in a new home if needed.
 14. The Buyer agrees to notify the Breeders of any health problems or death of the above dog.
 15. This contract constitutes the entire agreement of the Buyer and the Breeders and can only be modified by written agreement of both parties.

This agreement is made for the mutual benefit and protection of the Buyer, the Breeders, and above all, the Dog and the Briard breed.
