  - Specifically for alcohol prevention and reduction (using Safety First curriculum)
  - \$60,000/year for 4 years
  - Communication campaign with billboards, magazines, and newspapers and 6 alcohol/drug-free youth events (i.e. sports tournament(s), Rock the Dock partnership, etc)
