## FINANCIAL AGREEMENT

As the parent/guardian listed below, I understand and agree to be solely responsible for the 2023-24 season financial commitment as stated and agree to the TERMS & CONDITIONS. Financial agreement disputes or non-payment will be adjudicated in California Small Claims Court. Please initial acknowledgment of each item:

\_\_\_\_\_ All payments are non-refundable. Program Fees and Tuition are never pro-rated, including cases of illness/injury, joining late, leaving early, violating rules of conduct and or policy and procedures. If my child exits the program, due to any reason, before the end of the 2023-24 season, I understand I forfeit all payments & I will be charged a \$500 buy-out fee, which will be invoiced and due the day of termination.

\_\_\_\_\_ Merchandise (uniform, clothing, etc) will not be distributed if payments (tuition and/or fees) are past due.

\_\_\_\_\_ Past Due Actions. Balances that go 30 days or more past due will result in the athlete sitting out from practice and competitions until the account is brought current. Balances 45 days or more past due will be sent to a collection agency and will result in removal of the athlete from the program.

\_\_\_\_\_ Team members are not guaranteed specific positions (ie flyer, base) or level placement, that is done at the discretion of the coach/director.

\_\_\_\_\_ Missed team practice within 14 days of a competition may result in being replaced for that comp. Missed team practice during comp season months will result in a \$25 fee after allotted 3 (excused & unexcused). See absence policy and reporting.

\_\_\_\_\_ Returned items. Any returned checks or credit card transactions you will be charged an additional \$30 for item plus any fees incurred by Envious Athletics, Inc. No personal checks will be accepted going forward.

\_\_\_\_\_ Late Payment Fees. There will be a \$15 late fee assessed on all program fee and tuition payments that are made 10 or more days after due date.

\_\_\_\_\_ Fundraisers. Fundraising opportunities may be provided to parents to help offset the cost of participation. All funds raised go directly to account balances, can not be "cashed out" and are forfeited to Envious Athletics if program agreement is terminated by EA and/or athlete chooses to leave program.

## PARENT/GUARDIAN EXPECTATIONS

- + Negative Behavior will not be tolerated. We all need to work together to encourage and support all athletes on the team.
- + Do not post negative comments on Instagram, Facebook, or any other platforms about Envy Athletics teams or athletes.
- + Respect parents, coaches, athletes and administration for all teams. Envy Athletics needs to be role models of good sportsmanship. Both athletes and parents will cheer for our team, not against the opposing team.
- + Stay informed. Check your email, monthly calendars, and any other handouts regularly. If you are not receiving emails or text messages, contact the gym immediately.
- + Make sure your child is on time (10 min early) and ready for practice or events.
- + Work with Envy staff to support your child and their goals. Be positive and encouraging. If you have questions or are concerned with their progression or performance, make an appointment to meet with the coaching staff.
- + When my child is frustrated with the program, coach or teammates, I will support their need to vent to me. I will listen and offer constructive comments to help them resolve the conflict themselves whenever possible. If I feel it is necessary to contact the coach because my child is unable to resolve the conflict themselves, I will request a private meeting.
- + I will refrain from escalating any situation my athlete is experiencing by talking negatively to other members of the team, their parents, or the coach.
- + During events, please allow the team to prepare, cheer and perform without interruption. We need the athletes' full attention to prepare and perform to our best ability. Your child needs to make sure they have everything they need before the event. Parents are not allowed backstage.
- + I will wait 24 hours before contacting the coach if there is an incident or concern; unless it is a serious injury/incidence. Emotions often run high during a practice, competition or event, and a 24 hour waiting period gives both parties an opportunity to reflect on the issues at hand.
- + When meeting with the coach, I will refrain from accusations and harmful language. I will speak with respect and consideration. Personal attacks of athletes, coaching staff, and administration will not be tolerated. (which will be considered immediate dismissal)
- + I understand that as a parent, I can speak for myself but not the team as a whole. Each parent should address coaches and staff individually regarding their child or concerns.
- + I understand that my child's attention to the coach is vital to their safety when in the gym. I will not yell into the gym, distract my child or make contact through the windows or entrance. There will be NO outbursts by the parents tolerated whatsoever, this will result in restricting your access to the gym and waiting area.
- + I understand that the benefit of an individual will not be put ahead of the benefit of the team. Our coaches have your child's best interest, safety and success in mind at all times.

## ABSENCE POLICY

- + For the 2023-24 season, each athlete is allotted 3 absences from Sept. 1, 2022-May 31, 2024. These absences may not be used in the 14 days prior to a competition.
- + Allotted absences are used for illness, graded school functions, family commitments, or any other misc. personal events.
- + Prior to an absence, the absence form must be turned in. If the absence is due to illness, the absence form must be completed as soon as possible.
- + A \$25 fee will be charged for any absences after the allotted 3, excused or unexcused.
- + If your athlete misses a practice during the week prior to a competition, they will not be allowed to compete.
- + Our Summer policy is as follows:
  - + Choreography dates are mandatory, no absences allowed.
  - + If you are in town, you must be at your scheduled practice.
  - + We highly recommend planning vacations when the gym is closed.

## INJURY

- + Should an injury or illness occur, it is the responsibility of the parent/guardian to provide the front office with an injury/illness status from the doctor.
- + A release from a doctor is required prior to returning to practice or other gym activities if a serious injury occurred.
