



# **Chapel's Nest Off-Campus Student Residence**

## **Anti-Bullying Policy**

#### 1. Introduction

Chapel's Nest Private Student Residence is committed to providing a safe and supportive living environment for all residents. Bullying of any kind is unacceptable and will not be tolerated. This policy outlines our approach to preventing and addressing bullying incidents.

### 2. Definition of Bullying

Bullying is defined as repeated, unreasonable behaviour that is intended to harm, intimidate, or victimize another person. This can include:

- 2.1 Physical bullying (e.g., hitting, pushing, kicking)
- 2.2 Verbal bullying (e.g., name-calling, insults, teasing)
- 2.3 Social bullying (e.g., exclusion, spreading rumours)
- 2.4 Cyberbullying (e.g., online harassment, threats)

# 3. Principles

## Chapel's Nest Off-Campus Student Residence is committed to:

- 3.1 Providing a safe and supportive living environment for all residents
- 3.2 Promoting a culture of respect, empathy, and inclusivity
- 3.4 Encouraging open communication and reporting of bullying incidents
- 3.5 Taking prompt and effective action to address bullying incidents

# 4. Responsibilities

**4.1 Residents:** Treat others with respect and kindness, and report any bullying incidents to residence staff.





- **4.2 Residence Staff:** Provide support and guidance to residents, investigate bullying incidents, and take prompt action to address them.
- **4.3 Management:** Oversee the implementation of this policy, provide training and resources to staff, and review and update the policy as needed.
- 5. Procedures for Reporting and Addressing Bullying Incidents
- **5.1 Reporting:** Residents who experience or witness bullying should report the incident to residence staff as soon as possible.
- **5.2 Initial Response:** Residence staff will provide immediate support and guidance to the resident, and document the incident.
- **5.3 Investigation:** Residence staff will investigate the incident, speaking with all parties involved and gathering evidence.

#### 5.4 Action:

Depending on the severity of the incident, residence staff may take disciplinary action against the perpetrator, provide counselling or support to the victim, and implement measures to prevent future incidents.

# 6. Consequences of Bullying

Bullying behaviour will not be tolerated and may result in:

- 6.1 Verbal warning and counseling
- 6.2 Written warning and disciplinary action
- 6.3 Eviction from the residence
- 6.4 Reporting to university authorities or law enforcement





## 7. Support and Resources

Chapel's Nest Off-Campus Student Residence provides support and resources to residents who experience bullying, including:

- 7.1 Counselling and pastoral care
- 7.2 Peer support and mentoring programs
- 7.3 Referral to university support services

## 8. Review and Update

This policy will be reviewed and updated annually, or as needed.

### 9. Approval
