Deputy Mayor Gustafson led the Board in the Pledge of Allegiance at 7:00 pm.

## AUDIENCE:

Mr. Bush was present to discuss the upcoming Memorial Day Parade with the Board. He passed out a listing of the participating bands, speakers, as well as a schedule of events. He was excused at 7:19pm.

Fire Chief Chilson was present to ask for amendments to the 2022-2023 budget. They are as follows:

\$2000 to line 3410.4 Building Maintenance, to upgrade heating and repair dry rot on building \$4000 to line 3410.4 Computers, Pagers, Radio, to upgrade radios.

\$1300 to line 3410.4 Equipment Repair, for pumper testing.

Chief Chilson also asked that we look into the reserve account to see that all funds that are supposed to be available have been transferred.

Ken Johnston was present to discuss a few items with the Board. There is a tree on 29 N. Main Street that is dying, it will need to be looked at and revisited after Memorial Day. Mayor Brim has banners for Mr. Johnston to hang by the end of the week. Ken will also clean up a pine tree that has fallen on the canal trail before Memorial Day. Mr. Johnston was excused at 7:39pm.

Public Safety:

Mayor Brim met with Chris Carrick via zoom to discuss the solar project. Mr. Carrick has requested that Mayor Brim take updated photos of the DPW so that they have a better reference of where solar panels can go.

Motion offered by Deputy Mayor Gustafson to approve the Lock Tender's Proposal to submit to the Jordan Historical Society, seconded Trustee Stapleton. All present voting in favor, motion carried.

Motion offered by Trustee Stapleton to hire Gordon Pitre as a temp worker for the summer at a rate of \$14/hour. Motion seconded by Deputy Mayor Gustafson. All present voting in favor, motion carried.

Motion offered by Trustee Bates to approve sidewalk work to be completed by M&B flooring for water break repairs. Motion seconded by Deputy Mayor Gustafson. All present voting in favor, motion carried.

Motion offered by Deputy Mayor Gustafson to authorize the Village Office and DPW to close at 1:00pm on Friday, May 27<sup>th</sup>, pending completion of tasks. If the office needs, they can close and lock the door at 1:00pm and remain to work uninterrupted. Motion seconded by Trustee Stapleton. All present voting in favor, motion carried.

Motion offered by Deputy Mayor Gustafson to adopt the 2022/2023 Pool Budget. Motion seconded by Trustee Bates. All present voting in favor, motion carried. Motion offered by Deputy Mayor Gustafson to amend the 2022-2023 Budget Line A1910.4, Insurance General, from \$16,000 to \$16,182.90 to account for a rise in ESA Policy from last year. Motion seconded by Trustee Bates. All present voting in favor, motion carried. Motion offered by Deputy Mayor Gustafson to authorize Clerk Powers to make any necessary end of year transfers to zero out any negatives within individual budget lines within A, F, G, and CR accounts. An account of the transfers will be provided to the Board. Motion seconded by Trustee Bates. All present voting in favor, motion carried. Motion offered by Trustee Bates to amend the 22-23 Fire Department Budget lines as follows:

A3410.4: Building Maintenance, \$10,300

A3410.4: Computers, Pagers, Radios, \$8,000

A3410.4: Building Maintenance, \$5,000

Motion seconded by Deputy Mayor Gustafson. All present voting in favor, motion carried.

Motion offered by Deputy Mayor Gustafson to pay bills and file correspondence and seconded by Trustee Bates. All present voting in favor, motion carried.

Motion offered by Deputy Mayor Gustafson and seconded by Trustee Stapleton to adjourn the meeting. All present voting in favor. Motion carried at 8:42pm.
