

VILLAGE OF JORDAN
Special Meeting / Joint Board Meeting
Village of Jordan, Village of Elbridge and Town of Elbridge
Joint Water System Improvement Project
April 25, 2023

Meeting was called to order at 7:01 pm, at the Jordan Elbridge Community Center

Roll Call attendance was as follows: Town of Elbridge called by Town Clerk, Danielle Karlik, present were Supervisor Vern Richardson, Councilor Dugar, Councilor Blumer and Councilor Platten, absent was Councilor Caron. Village of Elbridge called by Clerk-Treasurer Tammy Kunz, present were Mayor Chris DeCola, Trustee DeMarco, Trustee Ely, Trustee Ellingworth, Trustee Harris (arrived at 7:08). Village of Jordan called by Deputy Clerk-Treasurer Redonna Geelan, Present were Mayor Brim, Trustee Bates, Trustee Gustafson, Trustee Simko and Trustee Stapleton.

Representatives from Barton and Loguidice, DPW employees, office employees and numerous residents were in attendance.

Town Supervisor Richardson opened the meeting at leading the group in the Pledge of Allegiance.

Town Supervisor Richardson then turned the meeting over to Taylor Bottar and Carley Parker of Barton and Loguidice who began a slideshow presentation.

Review of how the project began in 2019, the scope of the project including tanks, additional piping and distribution improvements. Ms. Parker continued the presentation with an explanation of Kingston Road pump station along with examples. Then explained PFAS, highlighting examples and health concerns. Taylor expressed that this testing is newer, and violations include Rolling Hills and Mobile Manor. Also, mentioned Sunview Drive, which is between the two trailer parks and choose to not be a part of the Joint Water System Improvement Project. Samples have been taken and waiting for results. Suggested steps to proceed, projects costs and grant funding were discussed. Presented a project cost options chart and a review of different costs based on various scenarios. B&L finished the presentation with a project schedule.

Supervisor Richardson opened the floor up for questions.

Several questions were asked by residents, and most were addressed. Some highlights included explanations of history of our current water system by Fred DiRisio and Pat Byrnes, Village of Jordan DPW. Our system is primarily from the 1930's. This new system will provide a constant flow with consent pressure to all residents, which has not been the case with the current one.

Mayor DeCola expressed the costs of the constant water main brakes, and why we should move forward with this project. We need to address the aged system. With the three municipalities on board will save money as well.
