- Hayleys Haven Canine Academy requires that your dog be vaccinated from DHPP, Rabies, and Kennel Cough prior to boarding.
- Hayley's Haven Canine Academy also requires that your dog has been treated for fleas/ticks prior to boarding as well
- Please provide proof of this upon drop off or via email.

Agreement between Hayleys Haven Canine Academy and Pet Owner:

- Hayleys Haven Canine Academy shall not be held responsible for any liability with respect to the dog(s) listed in this agreement, of any kind, character, or nature whatsoever, arising out of or from the boarding of the dog(s), or any damages which may accrue from any other cause whatsoever, including loss by fire, theft, running away, injury to persons, animals or property, unavoidable cause, or death or injury to any other animal caused by the within

names dog(s) during the term of this contract, weather this dog(s) be on premises of the property or not. Owner agrees to be and is solely responsible for all acts of behavior of said dog(s) at any time within the term and time of the contract. In no case shall Hayleys Haven Canine Academy be in any way liable or responsible.

- Owner specifically covenants, warrants and represents the following

A) He/She is the sole owner of said animal(s)

B) There is not now any lien or mortgage against said animal(s); and

C) The animal has not been exposed to distemper, parvo, or rabies within the last thirty days, and that the required vaccines have been obtained to prevent said sicknesses.

- If the animal(s) become ill, or Hayleys Haven Canine Academy suspects the animal(s) is ill, the owner will be notified at once, collect, if possible, or such attempt shall be made to notify the owner, and if the owner does not immediately inform Hayleys Haven Canine Academy regarding measures to be taken, or if the state of the dog requires quick action, the right to a veterinarian,

to administer medicine, or to give advisable attention to within the discretion of Hayleys Haven Canine Academy, and such expenses reasonable in amount shall be promptly paid by Owner.

- The animal(s) will not be taken off the property unless the owner is made aware prior to, the animal(s) needs to be rushed to a vet or required by legal authority.
- In the event of abandonment of the dog; According to the statutory abandonment provisions (Civil Code Section 1834.5), IF AN ANIMAL IS NOT PICKED UP WITHIN 14 DAYS AFTER IT WAS INITIALLY DUE TO BE PICKED UP, IT IS CONSIDERED TO BE ABANDONED. Hayleys Haven Canine Academy will be responsible for legal ownership of the dog after the 14 day mark and have legal rights to rehome, shelter, or euthanize said dog.
- If said dog is not abandoned and owners can no longer continue ownership of the dog, the owners will be required to sign over guardianship of the dog to Hayleys Haven Canine Academy to either rehome, shelter, or euthanize said dog.

## Severability

- The invalidity of any portion of this agreement will not and shall not be deemed to affect the validity of any other provision. If any provision of this agreement is held invalid, the parties agree that the remaining provisions of this agreement shall be deemed to be in full force and effect as if they had been executed by both parties after the expungement of the invalid provision.

## No Waiver

- The failure of either party to this agreement will not insist upon the performance of any of the terms and conditions of this agreement, or the waiver of any breach of any of the terms and conditions of this agreement, shall not be construed as subsequently waiving any such terms and conditions, but the same shall continue and remain in full force and effect as if no such forbearance or waiver had occurred.

## Governing Law

- This agreement shall be governed by, constructed, and enforced in accordance with the laws of the State of Texas.

## Notices:

- Any notice provided for or concerning this agreement shall be delivered in person to one another.

## Entire Agreement

- This agreement shall constitute the entire agreement between the parties and any prior understanding or representation of any kind preceding the date of this agreement shall not be binding upon either party except to the extent incorporated in this agreement

## Modification of Agreement

- Any modification of this agreement or additional obligation assumed by either party in connection with this agreement shall be binding only if placed in writing and signed by each party or an authorized representative of each party

## Assignment of Rights

- The rights of each party under this agreement are personal to that party and may not be assigned or transferred to any other person, firm, corporation, or other entity without the prior, express, and written consent of the other party.



- In this contract, any reference to a party includes that party's heirs, executors, successors and assigns, singular includes plural and masculine includes feminine.
